



**Sergeant Archibald Ash (Regimental Number 575) is buried in Sully-Saillisel British Cemetery – Grave reference II. A. 5.**

**His occupation previous to military service recorded as that of an electrical engineer working for fifteen dollars a week, Archibald Ash presented himself at the *Royal National Mission to Deep sea Fishermen* – was this at the *George V Institute on Water Street, St. John's*, capital city of the Dominion of Newfoundland ? - on September 19 of 1914 – six weeks and four days after the *Declaration of War* on August 4 – for a medical examination. It was an exercise which was to pronounce him as...*Fit for Foreign Service.***


Three days later, on September 22, Archibald Ash found his way to the *C.L.B. Armoury* for enlistment, whereupon he was engaged at the private soldier's daily rate of a single dollar plus a ten-cent per diem *Field Allowance*. A recruit of the First Draft, he was likely now ordered to the tented area by that time established on the shores of *Quidi Vidi Lake* in the East End of St. John's where a four-five week course of training was already under way. It was during this period that he was awarded his lance corporal's stripe, only six days after enlistment, on the 28<sup>th</sup> day of the month.

The regimental authorities were *also* busy by now, preparing for the transport of this, the first body of volunteers, to *overseas* - and later to *active* - *service*.

At the beginning of the month of October a large number of the new recruits underwent attestation; Lance Corporal Ash was one of that number, taking his oath of allegiance on the second day of October.

Two days later, after the Newfoundland contingent - it was not as yet a battalion - of 'A' and 'B' Companies had paraded through the city, it embarked onto the Bowring Brothers' vessel *Florizel* which was awaiting in St. John's Harbour.

Lance Corporal Ash and his comrades-in-arms of the *First Five Hundred* - also to be known to history as the *Blue Puttees* - were now to sit on board ship for the best part of a day as it was not to be until the morrow that *Florizel* would sail to the south coast of the Island and to its rendezvous with the convoy carrying the Canadian Division to the United Kingdom.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at Fort George - on the Moray Firth close to Inverness; and lastly at Edinburgh Castle where the unit was to provide the first garrison from outside the British Isles.

Some three months later, on May 11, and some seven weeks into spring - although in Scotland there was apparently still snow - the entire Newfoundland unit - by now 'A' and 'B' Companies re-enforced by 'C', 'D', and 'E' - was ordered moved from the Scottish capital to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent received the re-enforcements from home – ‘F’ Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. The now-formed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus rendered ready to be ordered on ‘active service’.

*\*The number was about fifteen hundred, sufficient to provide four ‘fighting’ companies, two re-enforcement companies and a headquarters staff.*

At the beginning of that August of 1915, the four senior Companies, ‘A’, ‘B’, ‘C’ and ‘D’ were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot.

This force, now designated as the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior companies, the later-arrived ‘E’ and the aforementioned last-arrived ‘F’, were ordered transferred to Scotland’s west coast, to Ayr, there to provide the nucleus of the newly-forming 2<sup>nd</sup> (Reserve) Battalion.

It was while he was at *Stobs Camp*, on a date – illegible - in June of that 1915, that Lance Corporal Ash received further promotion, on this second occasion to the rank of corporal.

\* \* \* \* \*

The newly-promoted Corporal Ash was not to travel south with the four senior companies of the Newfoundland Battalion for further training at Aldershot, nor would he sail with them to the Middle East and to *Gallipoli*; instead, he was posted to the new Regimental Depot along with the late arrivals from Newfoundland, ‘E’ and ‘F’ Companies.

At the end of that summer of 1915, the once-Royal Borough of Ayr on Scotland’s west coast was to begin to serve as the overseas base for the 2<sup>nd</sup> (Reserve) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the 1<sup>st</sup> Battalion’s numbers, at first to the Middle East and then later to the *Western Front*.

It was while he was serving at Ayr that, on October 1, 1915, Corporal Ash re-enlisted for the duration of the war\*. It was also during this same posting at the Regimental Depot, that a third promotion was received and he was appointed to the rank of sergeant on February 3, 1916.


*\*At the outset of the War, perhaps because it had been felt by the authorities that it would be a conflict of short duration, the recruits enlisted for a single year. As the War progressed, however, this was likely to cause problems and the men were encouraged to re-enlist.*

On October 3 of 1916, some fourteen months after his posting to Ayr, Sergeant Ash was on his way to the *Western Front* as a non-commissioned officer of the 11<sup>th</sup> Re-enforcement Draft, embarking through the English south-coast port of Southampton en route to the large British Expeditionary Base Depot at Rouen, the capital city of Normandy. His unit disembarked there on the next day, the 4<sup>th</sup>, making its way to the Base Depot for final training\* and for last-minute organization before moving on to a rendezvous with the 1<sup>st</sup> Battalion.

*\*Apparently the standard length of time for this final training at the outset of the war had been ten days – although this was to become more and more flexible as the War progressed - in areas near Rouen, Étapes, LeHavre and Harfleur that became known notoriously to the troops as the Bull Rings.*

It was a large detachment of two-hundred sixty-six *other ranks* which was to report to the Newfoundland Battalion transport lines on October 12. That was also the day on which 1<sup>st</sup> Battalion made its attack on the enemy positions at Gueudecourt (see further below). So it was that the new-comers would remain behind the lines until the 14<sup>th</sup>, two days later, when they were moved up to *Switch Trench* and parcelled out to the Battalion's four depleted fighting companies.

All those fourteen months before, while Lance-Corporal Ash and the two junior companies were beginning their time of training at Ayr in the summer of 1915, those aforementioned four senior companies, 'A', 'B', 'C' and 'D', of the Newfoundland Regiment, having now become its 1<sup>st</sup> Battalion, had thereupon been attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force and had been despatched to *active service*.

On August 20 of 1915, the Newfoundland Battalion had embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* on that September night, they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion were to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

*\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.*



November 26 would see the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

On the night of December 19-20, the British had abandoned the area of *Suvla Bay* – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard. Some of the Battalion personnel had been evacuated to the nearby island of *Imbros*, some to *Lemnos*, further away, but in neither case was the respite to be of a long duration; the 1<sup>st</sup> Battalion was to be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had now only been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation would take place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

Immediately after the British had evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15<sup>th</sup> of that month. The Newfoundlanders were then to be immediately transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division had yet to be decided\*.



*\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.*

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and *other ranks* of the 1<sup>st</sup> Battalion were to board His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage through the *Suez Canal* en route to France. The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseilles, on March 22.

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.


Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they had then marched on their way from the station. But some three months later *the Somme* was to become a part of their history.

On April 13, the 1<sup>st</sup> Battalion had subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive reinforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was to then be ordered to move further up for the first time into forward positions on April 22.



*\*It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Maily-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

*\*Perhaps ironically, the majority of the Battalion’s casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action* or *died of wounds*.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the butchery of *the Somme* was to continue for the next four and a half months.

*In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man’s-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.*

After the events of the morning of July 1, 1916, such had then been the dire condition of the attacking British forces that it had been feared that a German counter-assault might well annihilate what had managed to survive of the British Expeditionary Force on *the Somme*.

The few remnants of the Newfoundland Battalion – and of the other depleted British units - had thus remained in the trenches perhaps fearing the worst, and at night searching for the wounded and burying the dead. It was to be July 6 before the Newfoundlanders were to be relieved from the forward area and to be ordered withdrawn to Englebelmer.



It had then been a further two days before the unit had marched further again to the rear area and to billets in the village of Mailly-Maillet.



There on July 11, a draft of one-hundred twenty-seven re-enforcements – a second source cites one-hundred thirty – had reported *to duty*. They had been the first to arrive following the events at Beaumont-Hamel but even with this additional man-power having arrived, the Regimental War Diary records that on the 14<sup>th</sup> of July, 1916, the 1<sup>st</sup> Battalion still numbered only... *11 officers and 260 rifles...* after the holocaust of Beaumont-Hamel, just one-quarter of establishment battalion strength.

On July 27-28 of 1916, the 1<sup>st</sup> Battalion - still under establishment battalion strength at only five-hundred fifty-four strong, even after further re-enforcement – had moved north and entered into the *Kingdom of Belgium* for the first time.

It had been ordered to the *Ypres Salient*, one of the most dangerous pieces of real estate on the entire *Western Front*, there to continue to re-enforce and to re-organize after the ordeal of Beaumont-Hamel.

*The Salient* – close to the front lines for almost the entire fifty-two month conflict - was to be relatively quiet during the time of the Newfoundlanders' posting there; yet they nonetheless incurred casualties, a number – fifteen? - of them fatal.

Then on October 8, after having served in Belgium for some ten weeks, the Newfoundland Battalion had been ordered to return south, back into France and back into the area of – and the battle of – *the Somme*.





Four days after that return to France, on October 12, 1916, the 1<sup>st</sup> Battalion of the Newfoundland Regiment had again been ordered to the offensive; it was to be at a place called Gueudecourt, the vestiges of a village some dozen or so kilometres to the south-east of Beaumont-Hamel.

The encounter had proved to be another ill-conceived and costly affair – two hundred and thirty-nine casualties all told - for little gain.

This, then, was the situation into which Sergeant Ash and his re-enforcement draft was to march on that October 12, two days later each soldier to take his place in the trenches of Gueudecourt.

The Newfoundland Battalion was not now to be directly involved in any further concerted infantry action in the immediate area of Gueudecourt although, on October 18, it would supply two-hundred fifty men to act as stretcher-bearers in an attack undertaken by troops of two British regiments, the Hampshires and the Worcestershires, of the 88<sup>th</sup> Brigade.

On October 30, the Newfoundland unit had eventually been retired to rear positions from the Gueudecourt area. It had been serving in front-line and support positions for three weeks less a day.

The Newfoundlanders were now to spend two weeks withdrawn to the area of Ville-sous-Corbie, re-enforcing and reorganizing. It was not to be until November 15 that the 1<sup>st</sup> Battalion began to wend its way back up to the front lines.



There it continued its watch in and out of the trenches of *the Somme* – not without casualties – during the late fall and early winter, a period broken only by another several weeks spent in *Corps Reserve* during the Christmas period, encamped well behind the lines and in close proximity to the city of Amiens.



It had been on January 11 that the Newfoundland Battalion was to be ordered out of *Corps Reserve* and its lodgings at *Camps en Amienois* from where it would make its way on foot to the community of Airaines. From the railway station there it was to entrain for the small town of Corbie where it had thereupon taken over billets which it had already occupied for a short period only two months before.

After that recent six-week Christmas respite spent in *Corps Reserve* far to the rear, the Newfoundlanders were to *officially* return to *active service* on January 23, although they apparently had already returned to the trenches by that date and had incurred their first casualties – and fatality – of 1917.

Those casualties, however, were only some of those everyday thousands whom Douglas Haig casually referred to as *wastage* as the Newfoundland unit had not ventured from its trenches.

On January 27, the Regiment War Diary entry of the day notes: “*C*” *Company* were out helping to bring in wounded & carrying up material for consolidation purposes... One of those involved was to be Sergeant Ash (see below).



From this time on, however, the sole infantry activity *directly* involving the Newfoundland unit during that entire period – from Gueudecourt in mid-October, 1916, until Monchy-le-Preux in mid-April of 1917 – was to be the sharp engagement at Sailly-Saillisel at the end of February and the beginning of March, an action which would bring this episode in the Newfoundlanders’ War – in the area of *the Somme* - to a close.

A week prior to that engagement the Newfoundland Battalion had moved up from the rear to take over positions in the firing-line in the vicinity of the abandoned community of Sailly-Saillisel, there to relieve the 1<sup>st</sup> Battalion of the Lancaster Fusiliers.

Part of the entry of the 1<sup>st</sup> Battalion War Diary for February 23 reads: *Strict orders were given that gas-helmets were to be worn at alert position as enemy had been making frequent use of gas shells. Fairly lively enemy bombardment while Batt. going in. Casualties, 1 killed, 3 wounded, 1 gassed.*

The son of George Edward Ash and Sarah Frances Ash of Red Bay, Straits of Belle Isle, Labrador - before Labrador was to become part of the *Dominion of Newfoundland* – he was also brother to Frederick. Sergeant Ash's own address was recorded as St. Anthony.

A member of the *Legion of Frontiersmen* at the time of his enlistment, Sergeant Ash was reported as having been *killed in action* while serving with 'A' Company on that February 23, 1917, by enemy artillery fire while 1<sup>st</sup> Battalion was moving up to and into the line at Sailly-Saillisel.

Archibald Ash had enlisted at a *declared* twenty-three years of age.

The remains of Sergeant Ash were originally interred in a cemetery at Combles by a Reverend A. Clayton. They were later transferred to the site close to Sailly-Saillisel where they repose today. At home it was the Reverend B. P. Pardy who was requested to bear the news to his family.

Sergeant Ash was mentioned posthumously in despatches on April 9, 1917: *'Action Date, January 27th, 1917 – Lesboeuifs: On January 27th, 1917, when another unit had made a successful attack, Sgt. Ash went out in front and bandaged up wounded under very heavy shell fire. He directed the stretcher bearers and made several trips with them. Later on, he went out three times searching the ground for wounded until he was satisfied no more remained. The fire was heavy the whole time and he showed a total disregard for danger and set a great example to the stretcher bearers working with him.'*
