



**Private John Galpin (Regimental Number 1526) lies buried in Longueval Road Cemetery: Grave reference B. 1.**

His occupation prior to military service recorded as that of a *seaman* and earning an annual three-hundred dollars, John Galpin presented himself for medical examination at the *Church Lads Brigade Armoury* in St. John's, capital city of the Dominion of Newfoundland, on May 4 of 1915. It was a procedure which was to pronounce him as being...*Fit for Foreign Service.*

Three days after that medical assessment, on May 7, he returned to the *CLB Armoury* on Harvey Road, on this second occasion for enlistment. There John Galpin was to be engaged at the private soldier's daily rate of a single dollar to which would be added a ten-cent per diem Field Allowance.

There was now to pass but four final days before, on May 11, he would undergo his attestation, to swear his *Oath of Allegiance*, the concluding official formality. At that moment John Galpin became...*a soldier of the King*.

*\*Another source has him attesting on May 3, four days before his enlistment – perhaps unlikely.*

Thereupon followed a lengthy waiting period of six weeks less two days before Private Galpin, Regimental Number 1526 was to embark onto His Majesty's Transport *Calgarian* on June 20 – a second source has June 17 - in St. John's Harbour and sail (*almost\**) directly to the United Kingdom. He was one of the two-hundred forty-two men of 'F' Company and eighty-five naval reservists to take passage on that day.


Where Private Galpin was to spend the interim between his attestation and his departure on...*overseas service*...is not clear – and is not documented among his papers.

It may be that he returned temporarily to work and possibly that he was to spend some time at his home in the Newfoundland west coast community of Codroy - but this of course is only speculation.

'Calgarian' was not a requisitioned troop transport but in September of 1914 had been taken over by the British government to serve as an armed merchant-cruiser. She did, however, as on this occasion, at times carry troops and civilian passengers across the Atlantic. She was later torpedoed and sunk by U-19 off the north of Ireland on March 1, 1918.*)

*\*Apparently the ship took nineteen days to make what was usually the journey of about a week. Not only was Calgarian escorting three submarines, but she sailed by way of the Portuguese Azores and then Gibraltar – some of the Newfoundlanders apparently even having the time to cross the straits to spend a few hours in North Africa. She reached Liverpool on July 9.*

On the day after its arrival in the United Kingdom, 'F' Company travelled from Liverpool by train to Hawick from where the detachment marched and then reported...*to duty...at Stobs Camp* on the evening of July 10. It was an important moment: the Newfoundland Regiment, as of that day counting fifteen hundred personnel\*, was now at establishment strength and could be posted on...*active service*.




*\*A number sufficient to furnish four 'fighting' companies, two re-enforcement companies and a headquarters staff.*

Almost nine months before that June 20 of 1915, in the late summer and early autumn of 1914, the newly-formed Newfoundland Regiment's first recruits had undergone a period of training of five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's and elsewhere in the city, they to become 'A' and 'B' Companies.



During that same period the various authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

Once having disembarked in the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915:

firstly in southern England on the *Salisbury Plain*; then in Scotland at *Fort George* – on the *Moray Firth* close to Inverness; and lastly at *Edinburgh Castle* – where it was to provide the first garrison from outside the British Isles.

Only days after ‘A’ and ‘B’ Companies had taken up their posting there, on February 16 of 1915, ‘C’ Company – the first re-enforcements for the original contingent - would arrive directly – through Liverpool of course - from Newfoundland. On the final day of the month of March it had been the turn of ‘D’ Company to arrive – they via Halifax as well as Liverpool – to report...*to duty*...at Edinburgh, and then ‘E’ Company five weeks less a day later again, on May 4\*.



*\*These five Companies, while a contingent of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.*

Seven days after the arrival of ‘E’ Company in the Scottish capital, on May 11 the entire Newfoundland contingent was ordered elsewhere. On that day, seven weeks into spring – although in Scotland there was apparently still snow - the unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, close to the town of Hawick.

Two months less a day later, on July 10, ‘F’ Company marched into *Stobs Camp*.

\* \* \* \* \*

From *Stobs Camp*, some three weeks after the arrival of ‘F’ Company, in early August, ‘A’, ‘B’, ‘C’ and ‘D’, the four senior Companies, having now become the 1<sup>st</sup> Battalion of the Newfoundland Regiment, were transferred to *Aldershot Camp* in southern England. There they were to undergo final preparations – and a royal inspection – before departing to the Middle East and to the fighting on the *Gallipoli Peninsula*.

The later arrivals to the United Kingdom, ‘E’ and ‘F’ Companies, were to be posted to the new Regimental Depot and were eventually to form the nucleus of the soon to be formed 2<sup>nd</sup> (*Reserve*) Battalion of the Newfoundland Regiment.

The Depot was to be Private Galpin`s home for the next seven months.

At the end of the summer of 1915, the once-Royal Borough of Ayr on Scotland`s west coast was to begin to serve as the overseas base for what was to become the 2<sup>nd</sup> (Reserve) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the 1<sup>st</sup> Battalion`s numbers, at first to the Middle East and then later to the *Western Front*.

In was on February 1 of 1916 – some nine months after he had first enlisted - while he was still serving at the Regimental Depot, that Private Galpin was to *re-enlist* into the Newfoundland Regiment; on this occasion it was to be for the...*Duration of the War*\*. He had already seen the departure of the 1<sup>st</sup> Re-enforcement Draft from Ayr in mid-November on its way to *Gallipoli*, but had not been selected as a soldier of that initial detachment. For him at that time, there had been yet four months to wait.

*\*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for a limited period of a single year. As the War progressed, however, this would likely cause problems and they were encouraged to re-enlist. Later recruits signed on for the `Duration` at the time of their original enlistment.*

On March 13, six weeks less a day after re-enlistment, Private Galpin, as a soldier of the rank and file of the 2<sup>nd</sup> Re-enforcement Draft from Ayr, passed through the naval establishment of Devonport on the English south coast, en route – although nobody was aware of it at the time – for France. The Newfoundlanders were to travel to *the Continent* – western Europe - by way of Egypt\*.

*\*At the time there was some confusion as to whether the 1<sup>st</sup> Battalion as a unit of the 29<sup>th</sup> Division would stay in the Middle East or not, and this draft from Ayr apparently had orders to set sail for Egypt. However, there was surely a bureaucratic foul-up as the Newfoundland Battalion, once having arrived there, was then to re-embark in Egypt on only the following day for passage back to France.*

*The two ships – one carrying the re-enforcements eastward, the other carrying the parent 1<sup>st</sup> Battalion westward to France from Port Suez (see further below) - likely passed each other in the Mediterranean Sea, going in opposite directions.*

Private Galpin`s draft of one-hundred forty *other ranks*, under the command of Captain Ledingham, having disembarked in the French Mediterranean port-city of Marseille from HMT *Kingstonian* (right) on April 3, joined the Newfoundland Battalion on April 8 in the community of Louvencourt where the parent unit – still on its march towards the forward area of the *Western Front* - had already been billeted for two days.

While Private Galpin and his 'F' Company had been beginning their time of training at Ayr in the summer of 1915, the aforementioned four senior companies, 'A', 'B', 'C' and 'D', of the Newfoundland Regiment, having now become the 1<sup>st</sup> Battalion, had thereupon been attached to the 88<sup>th</sup> Infantry Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force and had been despatched to...*active service*.

On August 20 of 1915, the Newfoundland Battalion had embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion would now serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had been proving to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of their allies, the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

*\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.*

November 26 would see what perhaps was to be the nadir of the Newfoundland Battalion's fortunes at *Gallipoli*; there was to be a freak rain, snow and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, had been those afflicted by trench-foot and by frost-bite.

**By this time the situation there had daily been becoming more and more untenable, thus on the night of December 19-20, the British had abandoned the entire area of *Suvla Bay* – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard. Some of the Battalion personnel had thereupon been evacuated to the nearby island of *Imbros*, some to *Lemnos*, further away, but in neither case was the respite to be of a long duration; the 1<sup>st</sup> Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.**

**The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had by now simply been marking time until a complete withdrawal of the *Peninsula* could be undertaken.**

**This final operation would take place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.**

***\*Lieutenant Owen Steele of St. John’s, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.***

**Immediately after the British evacuation of the *Gallipoli Peninsula*, the Newfoundland unit had been ordered to the Egyptian port-city of *Alexandria*.**

On January 14, the Australian Expeditionary Force Transport *Nestor* had arrived there with the 1<sup>st</sup> Battalion on board. The vessel was to sail just after mid-day on the 16<sup>th</sup>, on its way southwards down the Suez Canal to Port Suez where she had docked early on the morrow and where the Newfoundlanders had landed and marched to their encampment.

There they were to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division had yet to be decided\*.

\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was already becoming a theatre of war.

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1<sup>st</sup> Battalion were to board His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage back up through the *Suez Canal* en route to France.

The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseille, on March 22.

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseille.




It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge which they had then traversed on their way from the station. But some three months later *the Somme* was to have become a part of their history.

And as related in an earlier paragraph, it was to be during the trek from Pont-Rémy towards the area of *the Front* that Private Galpin, accompanied by Captain Ledingham and the other personnel of the 2<sup>nd</sup> Re-enforcement Draft from Ayr – via Egypt – had reported...*to duty*...with the 1<sup>st</sup> Battalion on April 8 in the Community of Louvencourt.

\* \* \* \* \*

On April 13, the entire 1<sup>st</sup> Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was to then be ordered to move further up for the first time into forward positions on April 22.

*\*It should be remembered that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

*\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been...*killed in action...or...died of wounds.*

It was to be the greatest disaster ever in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for four and a half months.

*In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.*

Private Galpin was not one of those who figured in the fighting of the morning of July 1, 1916, with the Newfoundland Battalion at Beaumont-Hamel, but his name was included on the unit's nominal roll; it is therefore possible that he had been seconded to another unit or, more likely, that he was one of the ten per cent reserve of fourteen officers and eighty-three *other ranks* held at Louvencourt and not called forward until late in the afternoon of that day when the fighting had subsided.



*\*The well-known roll-call of July 2 of those who survived the battle unscathed was not officially recorded until two days later. The roll call of those who had been in the ten per cent reserve of fourteen officers and eighty-three men held back for most of the day at Louvencourt was apparently also recorded officially only later. Thus the inscription 'With Battalion 4/7/16' on certain records.*

After the catastrophic events of the morning of July 1, 1916, such was then the dire condition of the attacking British forces that it was to be feared that any German counter-assault might well annihilate what had managed to survive of the British Expeditionary Force on *the Somme*.

The few remnants of the Newfoundland Battalion – and of the other depleted British units - thus remained in the trenches perhaps fearing the worst, and at night searching for the wounded and burying the dead. It was to be July 6 before the Newfoundlanders were to be relieved from the forward area and to be ordered withdrawn to Englebelmer.

It would then be a further two days before the unit marched further again to the rear area and to new billets in the village of Mailly-Maillet.

There on July 11, a draft of one-hundred twenty-seven re-enforcements – a second source cites one-hundred thirty – reported...*to duty*. They would be the first to arrive following the events at Beaumont-Hamel but even with this additional man-power having arrived, the Regimental War Diary records that on the 14<sup>th</sup> of July, 1916, the 1<sup>st</sup> Battalion was still to number only... *11 officers and 260 rifles*...after the holocaust of Beaumont-Hamel, just one-quarter of establishment battalion strength.

On July 27-28 of 1916, the 1<sup>st</sup> Battalion - still under establishment battalion strength at only five-hundred fifty-four strong – maybe even fewer - even after further re-enforcement – moved northwards and entered into the *Kingdom of Belgium* for the first time.

It had been ordered to the *Ypres Salient*, one of the most dangerous pieces of real estate on the entire *Western Front*, there to continue to re-enforce and to re-organize after the ordeal of Beaumont-Hamel.




*The Salient* – close to the front lines for almost the entire fifty-two month conflict - was to be relatively quiet during the time of the Newfoundlanders' posting there; yet they nonetheless had incurred casualties, a number – fifteen? - of them fatal.



Apparently, Private Galpin suffered from hæmorrhoids (*piles*) and it was for that reason that he was admitted into the 3<sup>rd</sup> Canadian Casualty Station at the Rémy Sidings in the Belgian town of Poperinghe on September 19. He had been transferred by the following day, the 20<sup>th</sup>, to the 1<sup>st</sup> Convalescent Depot at Boulogne, before being forwarded to Base Depot on the 24<sup>th</sup>.

When Private Galpin re-joined the Newfoundland Battalion *in the field* appears not to be documented. It may have been during the final days of the unit's posting in Belgium: on October 5 the Regimental War Diary records a total complement of five-hundred twenty; three days later this total had become five-hundred ninety-five all told. There appears to be no documentation to explain this discrepancy – an unrecorded draft from Rouen? – or was it that Headquarters personnel had not been included in the first count?



Then again, he may have been among the small draft of twelve *other ranks* which is recorded as having joined the Battalion in the community of Corbie on October 8, the day on which the Newfoundland unit also arrived there after an eighteen-hour journey – the final ten kilometres on foot – from Poperinghe.

Whatever the case, Private Galpin was there in time to serve in the Battalion's next action.

As seen in an immediately above paragraph, on October 8, after having served in Belgium for some ten weeks, the Newfoundland Battalion had been ordered returned southwards, back into France and back into the area of – and the battle of – *the Somme*, to be joined on that date at Corbie by the returning Private Galpin.

Four days after that return to France, on October 12, 1916, the 1<sup>st</sup> Battalion of the Newfoundland Regiment again was ordered to the offensive; it was to be at a place called Gueudecourt, the vestiges of a village some dozen or so kilometres to the south-east of Beaumont-Hamel.

The encounter was to prove to be another ill-conceived and costly affair – two hundred and thirty-nine casualties all told - for little gain.




The son of John Galpin, former fisherman (deceased on December 12, 1913), and of Maria Galpin (deceased on March 7-8 of 1908) of Codroy in the District of St. George, he had allotted to his sister Jane and to her husband, Benjamin Kendall (also found as *Kendle*), of Bay St. George, a daily allowance of seventy cents from his pay. He was also brother to Israel, resident of Woody Head Cove, who was later to receive Private Galpin's Memorial Plaque and his medals.

Private Galpin was reported at first as having been...*wounded*...on October 12, 1916, while fighting with the Battalion – in either 'B' or 'C' Company - at Gueudecourt during the...*First Battle of the Somme*, having suffered injuries to a leg, to both arms and the head. He was later recorded as having...*died of wounds*...on that same day by the Officer Commanding the 36<sup>th</sup> Field Ambulance to where he had been evacuated.

At home, it was the Reverend E.A. Butler of the community of St. George who was requested to bear the news to his family.

John Galpin had enlisted at the *declared* age of twenty-seven years and nine months.

Private John Galpin was entitled to the British War Medal (left) and to the Victory Medal (Inter-Allied War Medal).
