

Private Harvey Newman Harris (Regimental Number 1114), having no known last resting-place, is commemorated on the bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.



His occupation previous to his military service recorded as that of a *labourer* working for a monthly thirty dollars, Harvey Newman Harris presented himself for medical examination in the Newfoundland south-coast community of Burgeo on January 20, 1915. It was a procedure which was to pronounce him as...*Fit for Foreign Service*.

Having then travelled to St. John's, capital city of the Dominion of Newfoundland, Harvey Harris enlisted four weeks less a day later at the *Church Lads Brigade Armoury* on Harvey Road on February 16 – engaged at the private soldier's rate of a single dollar per diem plus a daily ten-cent *Field Allowance.* 

Following his enlistment, whereas attestation for others had come about on the day of enlistment, he was now to await a further eight days, until February 24, before *that* last formality came to pass and he was to swear his *Oath of Allegiance*. He thereupon became...a soldier of the King.

For Private Harris, Number 1114, there was now to be yet another, and ultimate, waiting period of three weeks plus three days before he would be summoned to...*overseas service*. How he occupied himself during the interims is not recorded among his papers; he may, of course, have temporarily returned to work, perhaps even home to Burgeo, but this is only speculation.

Unlike the two previous contingents to have departed Newfoundland (see below) for...overseas service, Private Harris' 'D' Company was not to sail directly to the United Kingdom. On March 20 it, he as soldier of Number 6 Platoon, embarked onto the Bowring-Brothers' vessel Stephano for the short voyage to Halifax, capital city of the Canadian province of Nova Scotia, where it was thereupon to board a second vessel, the newly-launched Orduña for the trans-Atlantic crossing\*.

Having then sailed from Nova Scotia on March 22 for Liverpool, Private Harris and his draft landed there eight days later, on the 30<sup>th</sup>. Once disembarked in Liverpool, the two-hundred fifty men and officers of 'D' Company were thereupon transported on the same date by train directly to Edinburgh, the Scottish capital, to join the Newfoundland Regiment's 'A', 'B' and 'C' Companies.

These units were by this time stationed at the historic Castle, 'A' and 'B' having recently been posted from Fort George and 'C' having arrived directly from home (see further below). After 'D' Company's arrival at the end of that month of March, the Newfoundlanders were now to remain at Edinburgh for the following six weeks.

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the *Salisbury Plain*; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at *Edinburgh Castle* – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 'C' Company – the first re-enforcements for the original contingent\* - would arrive directly from Newfoundland.

\*This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.

\* \* \* \* \*

As seen in a previous paragraph, for the month of April and the first days of May of 1915, 'A', 'B', 'C' and 'D' Companies, now united, were to furnish the garrison – the first troops from outside the British Isles to do so - of the guardian of Scotland's capital city. Then, during the first week of May, 'E' Company was to report there...*to duty*...from home. Four days later again, on May 11, the Newfoundland contingent was ordered elsewhere.

On that day, some seven weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. The now-formed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus rendered available to be sent on 'active service'.

\*This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming  $2^{nd}$  (*Reserve*) Battalion.

For whatever the reason – maybe his young age was a factor – and despite the fact that he was a soldier of 'D' Company, Private Harris was not to serve in either *Gallipoli* or Egypt; he was posted instead to the Regimental Depot where he was to remain for some eight months until March 13 of 1916.

At the end of this summer of 1915, the once-Royal Borough of Ayr on Scotland's west coast was to begin to serve as the overseas base for the  $2^{nd}$  (*Reserve*) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the  $1^{st}$  Battalion's numbers, at first to the Middle East and then later to the *Western Front*.

It was to be there at Ayr that, on January 27 of the New Year, 1916, Private Harris was prevailed upon to re-enlist, on this second occasion...for the duration of the war\*.

\*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist. Later recruits eventually enlisted... 'For the Duration' at the very onset of their service.

Private Harris was now obliged to wait – he had already seen the 1<sup>st</sup> Re-enforcement Draft of November 14, 1915, depart on...*active service...*to the Middle East. It was not to be until March 13, almost the following spring, that he would embark at Devonport to join the 1<sup>st</sup> Battalion. With him was the 2<sup>nd</sup> Reinforcement Draft from Ayr en route for Egypt.

However, three weeks later, by this circuitous route, the detachment arrived in the French Mediterranean port of Marseilles on board His Majesty's Transport *Kingstonian*, on April 3-4, to join - not the Mediterranean Expeditionary Force in Egypt but - the British Expeditionary Force in France\*.

Four days later, on April 8, Captain Ledingham and Lieutenant W. J. Pippy, the two officers in command, arrived by train from Marseilles with the 2<sup>nd</sup> Re-enforcement Draft of onehundred forty...other ranks...to report...to duty...with the parent Newfoundland Battalion, also newly-arrived from Marseilles – see below - in the village of Louvencourt, in the northern Département de la Somme.

\*At the time there was some confusion as to whether the Newfoundland Battalion would stav in the Middle East or not, and this draft had likely already set sail for there before the 1<sup>st</sup> Battalion was ordered to France from Egypt. It may be their vessel had no wireless or it may be that some of the other units on board were needed in the Middle East, but no official reason for this curious situation seems to have been documented.

In the meantime, on August 20, 1915, during the early days of Private Harris' posting to Ayr, the 1<sup>st</sup> Battalion of the Newfoundland Regiment had embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner Megantic for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion was to land at Suvla Bay on the Gallipoli Peninsula.

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had been proving to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of their allies, the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.

November 26 of 1915 had perhaps seen the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous had been those afflicted by trench-foot and by frost-bite.

This then, was the situation into which the 1<sup>st</sup> Re-enforcement Draft from Ayr would step when it had set foot onto the sand and stone – mostly the latter – of Kangaroo Beach on the first day of December, 1915.

During the days that followed, the British positions at *Suvla Bay* – and thus also those of the Newfoundland unit - were to become yet more and more untenable and thus on the night of December 19-20, the area had been abandoned – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.

Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case had the respite been of a long duration; the Newfoundland Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had by then only been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation had taken place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

\*Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.

Immediately after the British evacuation of the *Gallipoli Peninsula*, the Newfoundland unit had been ordered to the Egyptian port-city of Alexandria. On January 14, the Australian Expeditionary Force Transport *Nestor* had arrived there with the 1<sup>st</sup> Battalion on board. The vessel was to sail just after mid-day on the 16<sup>th</sup>, on its way southwards down the Suez Canal to Port Suez where she arrived on the morrow and where the Newfoundlanders landed and marched to their encampment.



There they were to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division was yet to be decided\*.

\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was already becoming a theatre of war.

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and *other ranks* of the 1<sup>st</sup> Battalion boarded His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage through the *Suez Canal* en route to France.

The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseilles, on March 22.

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.



Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1<sup>st</sup> Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

And it will be remembered that it was at Louvencourt while the Newfoundland Battalion was on its way from Pont-Rémy to Englebelmer that Private Harris, from Ayr via Egypt and Marseilles, re-joined the parent unit.


Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

\*It should be said that the Newfoundland Battalion and twohundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been...killed in action...or...died of wounds.

It was to be the largest disaster *ever* in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for the next four and a half months.

\*In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

The son of William Henry Harris (deceased August 15, 1916?) and of Evelina (also found as *Evellena*) Harris (née *Guy*) - to whom he had allotted a daily allowance of seventy cents a day from his pay, and to whom he willed his everything - of Burgeo, he was also brother to Gilbert-Guy, to Gordon-Stanley and to a deceased sister.

Private Harris was reported as having been...*killed in action*...at Beaumont-Hamel on July 1, 1916, while serving with 'D' Company during the fighting of the first day of...*the Somme*.

Harvey Newman Harris had enlisted at a *declared* eighteen years of age: date of birth in Burgeo, Newfoundland, October 23, 1896 (from the Newfoundland Birth Register).

Private Harvey Newman Harris was entitled to the British War Medal (left) and to the Victory Medal (Inter-Allied War Medal).
