



Private Bert Jackman (Regimental Number 697) lies in Etretat Churchyard – Grave reference II. E. 4.

His occupations previous to military service recorded as being those of both *store-keeper* and *carpenter*, and working for a monthly thirty-five dollars, Bert Jackman presented himself for medical examination on December 3, 1914, at the *Church Lads Brigade Armoury* on Harvey Road in St. John's, capital city of the Dominion of Newfoundland. It was a procedure which was to pronounce him as...*Fit for Foreign Service.**

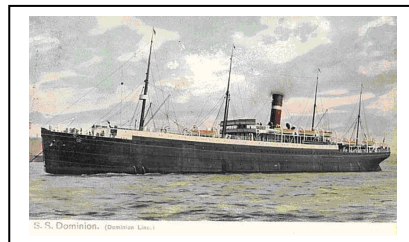

**Although Bert Jackman was a recruit of the Second Draft, it would appear, according to a paper written by his mother, that he had also volunteered during the First Draft but had been rejected at that time, the reason for which not to be found among his papers.*

Twelve days after his medical examination, Bert Jackman was to return to the *C.L.B. Armoury*, there to enlist – engaged at the private soldier’s daily rate of a single dollar a day plus a ten-cent *Field Allowance*. It appears that he was also to attest on that same December 15.

Now for Private Jackman, Number 697, there was to be a seven-week waiting period.

On the fourth day of February of 1915, the first reinforcements – this was ‘C’ Company - for the Newfoundland contingent – it was not yet at battalion strength - which by this time was serving in Scotland (see further below), were to embark via the sealing tender *Neptune* onto the *SS Dominion* – the vessel having anchored to the south of St. John’s, off Bay Bulls, because of ice conditions.



The vessel was then to sail - and Private Jackman thus departed Newfoundland for overseas service - a day later again, on February 5, for trans-Atlantic passage to the United Kingdom.

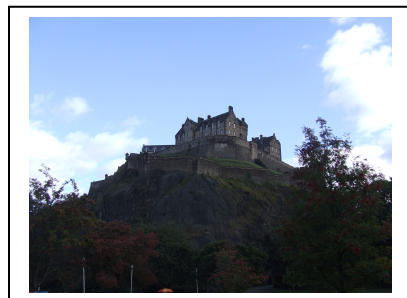


**There appears to be some confusion in some sources as to whether these troops were ‘C’ or ‘D’ Company. However, ‘D’ Company was to go overseas some time later on ‘Stephano’ to Halifax and then on ‘Orduña’ to Liverpool.*

Having disembarked in the English west-coast port-city of Liverpool, the Newfoundlanders entrained for Edinburgh, the first Newfoundland Regiment contingent having by this time been posted to the historic Castle in Scotland’s capital city. There they were to provide the garrison, thus being the first unit from overseas ever to do so.

Private Jackman and the other new-comers reported to duty at Edinburgh Castle on February 16.

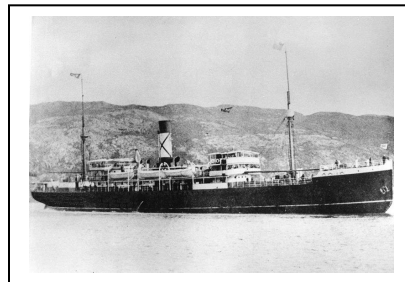


(Right above: Edinburgh Castle dominates the city from its position on the summit of Castle Hill. – photograph from 2011)

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits - to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.



The ship would sail for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1st Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles – and where 'C' Company and Private Jackman, as also cited beforehand, would arrive from Newfoundland on February 16 of 1915.

* * * * *

Some three months later, on May 11, and three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundlanders unit was ordered moved to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent received the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength*. The now-formed 1st Battalion of the Newfoundland Regiment was thus rendered eligible to be sent on 'active service'.



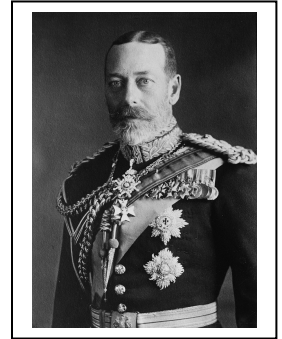

**This was approximately fifteen hundred, sufficient to furnish four 'fighting' companies, two re-enforcement companies and a headquarters staff.*

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1st Battalion of the Newfoundland Regiment, was thereupon attached to the 88th Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming 2nd (Reserve) Battalion.

However, although being a private soldier of 'C' Company, Private Jackman was not to travel to Aldershot and then beyond, but was to remain behind in the United Kingdom – for medical reasons. On August 3 he was admitted into hospital in Edinburgh; on the following day he was forwarded to the Glenmorse Hospital where he remained for only two more days; finally, on August 6, he was admitted into the Military Hospital at the Newcastle-on-Tyne Workhouse, there to receive treatment until September 28. He was suffering from a venereal problem.

Upon his release from hospital on the next day, September 29, Private Jackman was posted to the Regimental Depot at Ayr. There he was stationed for the next five-and-a-half months.

At the end of that summer of 1915, the once-Royal Borough of Ayr on Scotland's west coast was to begin to serve as the overseas base for the 2nd (Reserve) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the 1st Battalion's numbers, at first to the Middle East and then later to the *Western Front*.

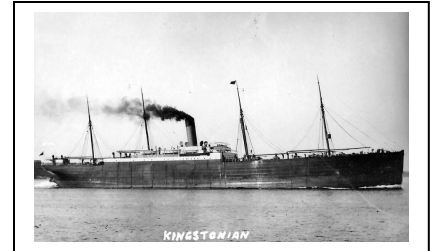

It was to be during this period while at Ayr that, on December 6, Private Jackman was prevailed upon to re-enlist, on this occasion *for the duration of the war**.

**At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.*

Private Jackman was once again obliged to wait and to watch as others – the 1st Re-enforcement Draft of November 14 – departed on *active service*. It was not to be until March 13 of 1916 that he embarked at Devonport to join the Newfoundland Battalion...*in the field*. With him was the 2nd Reinforcement Draft from Ayr, a detachment en route for the Middle East and – as it thought - Egypt.



However, three weeks later, by this circuitous route, the detachment arrived *from Alexandria* in the French Mediterranean port of Marseilles on board His Majesty's Transport *Kingstonian*, on April 3-4, there to join - not the Mediterranean Expeditionary Force in Egypt but - the British Expeditionary Force in France*.

Four days later, on April 8, Commanding Officers Captain Ledingham and Lieutenant W. J. Pippy arrived by train from Marseilles with their re-enforcement draft of one-hundred forty *other ranks* – Private Jackman among that number - to report *to duty* with the 1st Battalion in the village of Louvencourt, in the northern *Département de la Somme*.

**At the time there was some confusion as to whether 1st Battalion would stay in the Middle East or not, and this draft had likely already set sail for Egypt before the 1st Battalion was ordered to France from Egypt. It may be their vessel had no wireless or it may be that some of the other units on board were needed in the Middle East, but no official reason seems to have been documented. The ships likely passed each other en route.*

* * * * *

In the meantime, during those weeks spent at Aldershot in August of the preceding summer, the newly-formed 1st Battalion of the Newfoundland Regiment had been undergoing final organization before proceeding on...*active service*.

On August 20, 1915, the Newfoundland unit embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1st Battalion landed at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

**Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.*

During the short period which now followed, things were to worsen at *Gallipoli** for the British in general and the 1st Battalion of the Newfoundland Regiment in particular.

**The French know the campaign as 'Les Dardanelles' while the Turks call it 'Çanakkale'.*

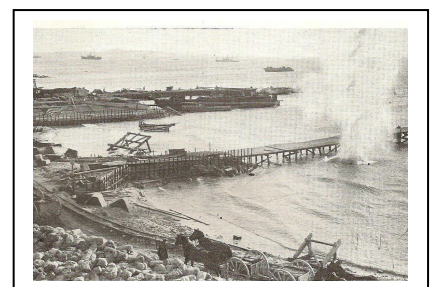
November 26 of 1915 had seen perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

As the days, weeks and months had passed at *Suvla Bay*, the British position there was to become more and more untenable and thus on the night of December 19-20, they had abandoned the area – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.



Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case had the respite been of a long duration; the 1st Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had by now only been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation had taken place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

**Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.*

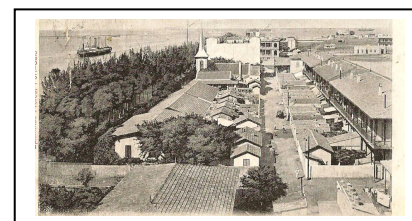
Immediately after the British had evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15th of that month. The Newfoundlanders had then immediately been transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29th Division had yet to be decided*.

**Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.*

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1st Battalion had boarded His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage through the *Suez Canal* en route to France. The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseilles, on March 22.

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train had found its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

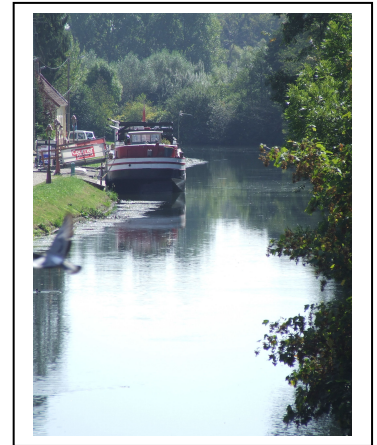
It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then had marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

It had been during this march of the next number of days that on April 8, during the period of a few days spent in billets in and in the vicinity of the community of Lovencourt, Private Jackman's 2nd Reinforcement Draft had arrived from Ayr – via Egypt – to report to duty.

* * * * *

On April 13, the 1st Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive further reinforcements from Scotland and, in two days' time, would then be introduced into the communication trenches of the *Western Front*.



Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

**It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2nd Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.

**Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action or died of wounds*.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.



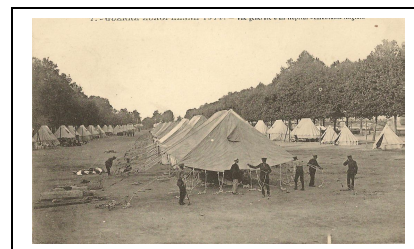

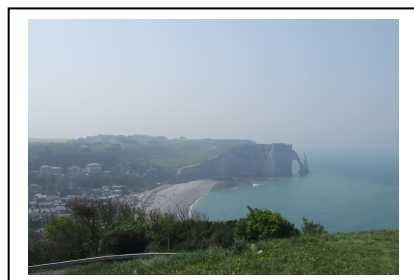
On July 1, 1916, during the fighting at Beaumont-Hamel on the first day of *the Somme*, Private Jackman incurred wounds to the thigh and shoulder while serving with 'A' Company. He was evacuated from the front to the 35th Casualty Clearing Station in the town of Doullens on July 2. From there, on July 3, he was transferred to the 1st General Hospital at the coastal peace-time resort of Etretat.

The son of Captain Francis (known as *Frank*) Jackman, harbour pilot, and of Ellen Jackman (née *Walsh*) – to whom he had allocated a daily sixty cents from his pay - of 33, Angel Place, St. John's, he was also brother to Arthur-Joseph*, Francis-Joseph, Patrick-Joseph, Ellen-Frances and to Catherine-Mary.

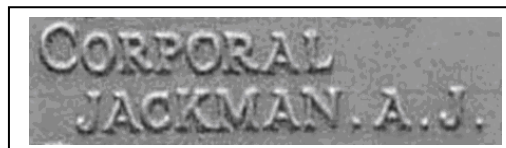


Private Jackman was reported as having *died of wounds* in hospital at Etretat at two o'clock in the morning of July 5, 1916. He was buried on that same day.

Bert Jackman had enlisted at the *declared* age of twenty-five years: date of birth in St. John's, Newfoundland, September 19, 1887 (from the Newfoundland Birth Register).

***His brother, Corporal Arthur Joseph Jackman – Regimental Number 533 - was to later be reported as missing in action during the fighting at Monchy-le-Preux on April 14, 1917, and on November 17 of that same year, to be presumed dead.**

He has no last resting-place and is commemorated beneath the Caribou at Beaumont-Hamel.
