

Lance Corporal Frederick Janes (Regimental Number 1275) is interred in Y Ravine Cemetery – Grave reference: D. 10.

His occupation prior to military service recorded as that of a *grocery clerk* employed by *G. Knowling, Importers and General Merchants*, and earning fifty dollars per month, Frederick Janes presented himself for medical examination on March 16 of 1915 at the *Church Lads Brigade Armoury* in St. John's, capital city of the Dominion of Newfoundland. It was a procedure which would report him as being...*Fit for Foreign Service*.

A single day following, on March 17, he returned to the *CLB Armoury* on Harvey Road, there to enlist – engaged at the private soldier's rate of a single dollar per diem, plus a daily ten-cent *Field Allowance*.

It was two weeks and a day later again after his enlistment that on March 30 he was to undertake his attestation, to swear his *Oath of Allegiance*, the concluding official formality. At that moment Frederick Janes became...a soldier of the King.

There now passed a lengthy period of twenty-two days before, on April 22, 1915, Private Janes, Number 1275, embarked in the harbour of St. John's for...overseas service...with the two-hundred forty-nine officers and...other ranks...of 'E' Company onto the Bowring Brothers' vessel Stephano en route for Halifax.

There appear to be no details of how or where he may have spent that final three-week period before taking ship for...overseas service; Private Janes may have returned temporarily to work, but this is mere speculation.

Having arrived in Halifax, on April 24 at eleven-thirty in the evening the detachment began its trans-Atlantic passage on board the trans-Atlantic liner SS *Missanabie* from Nova Scotia to Liverpool. The vessel arrived in that English west-coast port-city on May 2 or 3 – the two dates are recorded although the second may well have been the date of disembarkation.

The Newfoundlanders on this occasion had sailed from Halifax in the company of the Canadian Army Service Corps Railway Supply Depot.

On September 9, 1918, she was torpedoed and sunk off the south coast of Ireland with the loss of forty-five lives.)

From Liverpool the contingent travelled northwards by train to the Scottish capital, Edinburgh where, on May 4, 'E' Company joined 'A', 'B', 'C' and 'D' Companies which had already taken up station as the garrison at the historic Castle, the first troops from outside the British Isles ever to do so.

Private Janes and his 'E' Company, however, were to have but a few days to savour the charms of the Scottish capital.

* * * * *

Some seven months before that May 4, in the late summer and early autumn of 1914 there had been a period of training of five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1st Canadian Division overseas, off the south coast of the Island.

Once having disembarked in the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the *Salisbury Plain*; then in Scotland at *Fort George* – on the *Moray Firth* close to Inverness; and lastly at *Edinburgh Castle* – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 of 1915, 'C' Company – the first re-enforcements for the original contingent* - would arrive directly – through Liverpool of course - from Newfoundland. On the final day of the month of March it had been the turn of 'D' Company to arrive – they via Halifax as well as Liverpool – to report...to duty...at Edinburgh.

*This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.

* * * * *

Seven days after the arrival of 'E' Company in the Scottish capital, on May 11 the entire Newfoundland contingent was ordered elsewhere.

On that day, seven weeks into spring – although in Scotland there was apparently still snow - the unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength*. On that date the newly-formed 1st Battalion of the Newfoundland Regiment was thus now available to be ordered on...active service.

*This was approximately fifteen hundred, sufficient to furnish four 'fighting' companies, two re-enforcement companies and a headquarters staff.

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at *Camp Aldershot*. This force, now the 1st Battalion of the Newfoundland Regiment, was thereupon attached to the 88th Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – as seen, the last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming 2nd (*Reserve*) Battalion.

Private Janes, however, although having left Newfoundland as a soldier of 'E' Company, was not to be posted to the Regimental Depot but to southern England.

When he had been apprised of this change in plans seems not to be recorded – nor why he was selected - but Private Janes was one of the few from 'E' Company who were to swell the ranks of the units posted to *Aldershot* - thus he became a soldier of 'C' Company. And it was during the period while he was at *Camp Aldershot*, and as was the case with the great majority of the Newfoundland troops there, that Private Janes was prevailed upon to re-enlist... for the duration of the war. This he did on August 15*.


*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was likely to cause problems and the men were encouraged to re-enlist. Later recruits signed on for the 'Duration' at the time of their enlistment.




(Right: The image of Megantic, here in her peace-time colours of a 'White Star Line' vessel, is from the Old Ship Picture Galleries web-site.)

On August 20, 1915, Private Janes and his 1st Battalion embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1st Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.









Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had been proving to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and those of their allies, the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.

If the situation had been already tenuous by the time of the arrival of the Newfoundland Battalion at *Suvla Bay* on that September night, it was to become worse. November 26 of 1915 was to perhaps see the nadir of the Newfoundland Battalion's fortunes at *Gallipoli*; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, had been those afflicted by trench-foot and by frost-bite.

Private Janes was one of those.

* * * * *

On December 15, Private Janes – less than three weeks after the cataclysmic storm and only days before the British were to abandon the area - was evacuated from the Newfoundland positions at *Suvla Bay* onto His Majesty's Hospital Ship *Gloucester Castle* – a second source has HMHS *Hunslet*. He was suffering from a severe case of the aforementioned frostbite.


From Suvla Bay the ship sailed to the British-held Mediterranean island of Malta where, on December 22, he was admitted into the Military Hospital in the capital city of Valetta.

Built for the Union-Castle Line in 1911, the ship was requisitioned early in the War and towards the end of September of that 1914 was commissioned as a hospital ship capable of accommodating four-hundred ten bed-ridden patients.



On March 30, 1917, while carrying three-hundred sick and wounded - of which three-hundred cot cases - she was torpedoed while en route from France to England. Four lives were lost but Gloucester Castle was towed to Southampton and later repaired.)

On January 7 of the New Year, 1916, Private Janes was sent to the *All Saints' Convalescent Camp*, also on Malta, where he was to spend two weeks before then being discharged...to *duty*...(likely back to the British Sidi Bishr Base Depot in Alexandria).

On February 27, not yet re-united with his unit, Private Janes was promoted to the rank of lance corporal – with the accompanying five-cents-per-day raise in pay. Two days later, he was to travel – most likely from Alexandria on the Mediterranean Sea, from north to south down the Suez Canal, to the vicinity of Port Suez on the Red Sea where he reported...to duty...with the Newfoundland Battalion on March 1.

* * * * *

As has already been seen, as the days of the late autumn of that 1915 had passed, the plight of the British - and thus of the Newfoundlanders – had been daily becoming more and more untenable; thus on the night of December 19-20 - and four days after the despatch of Private Janes to hospital on Malta - the British had abandoned the entire area of *Suvla Bay* – the 1st Battalion, the only non-British unit to serve there, to form a part of the rear-quard.

Some of the Battalion personnel had been evacuated to the nearby island of Imbros, some to Lemnos, further away, but in neither case was the respite to be of a long duration; the 1st Battalion was to be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and Anzac forces – the Australian and New Zealand Army Corps was also to serve at Gallipoli – had now only been marking time until a complete withdrawal of the Peninsula could be undertaken.

This final operation would take place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

*Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.

Immediately after the British evacuation of the *Gallipoli Peninsula*, the Newfoundland unit had been ordered to the Egyptian port-city of Alexandria. On January 14, the Australian Expeditionary Force Transport *Nestor* had arrived there with the 1st Battalion on board. The vessel was to sail just after mid-day on the 16th, on its way southwards down the Suez Canal to Port Suez where she arrived on the morrow and where the Newfoundlanders landed and marched to their encampment.







There they were to await further orders since, at the time, the subsequent destination of the British 29th Division had yet to be decided*.

Australia. During the Great War she served mainly in the transport of Australian troops and was requisitioned once again in 1940 for government service in the Second World War. In 1950 she was broken up.)

*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was already becoming a theatre of war.

And it had been, of course, towards the end of those eight weeks to be spent by the 1st Battalion of the Newfoundland Regiment at Port Suez, that Private Janes, on March 1, had reported back to his unit.



On March 14, the decision by then having been taken to send the British 29th Division to serve on the *Western Front*, the officers and men of the 1st Battalion embarked through Port Tewfiq at the southern end of the Suez Canal onto His Majesty's Transport *Alaunia* for passage to the French Mediterranean port of Marseille, en route to the *Western Front*.


The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseille, on March 22.





Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseille. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they had then marched on their way from the station. But some three months later *la Somme* was to become a part of their history.

On April 13, the 1st Battalion had subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit* before the entire Newfoundland unit was to then be ordered to move further up for the first time into forward positions on April 22.

*It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2nd Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, the Somme, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went over the top in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.

*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.

There are other numbers of course: the fiftyseven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been killed in action or died of wounds.

It was to be the largest disaster *ever* in the annals of the British Army...and, perhaps just as depressing, the butchery of *the Somme* was to continue for four and a half months.







In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.





The son of Bertha Janes (nèe *Campbell*)* and of Alexander Janes**, tinsmith (his business established on Carter's Hill in the city) and mechanic – to whom he had allotted a daily allowance of fifty cents from his pay - of 36, Goodview Street in St. John's, he was also brother to Bessie and to Lilla-May.

*The couple had married on September 24, 1890.

Private Janes was reported as having been...killed in action...at Beaumont-Hamel on July 1, 1916, while serving with 'C' Company during the fighting of the first day of the...First Battle of the Somme.

Frederick Moses Janes had enlisted at a *declared* twenty-two years of age: date of birth in St. John's, Newfoundland, April 19, 1893 (from the Newfoundland Birth Register as is the name *Moses*).

He shares his grave marker with Private W. Miller of the Border Regiment.

*The family name is also to be found on certain (copies of) official lists as James.

Lance Corporal Frederick Janes was entitled to the 1914-1915 Star, as well as to the British War Medal (centre) and to the Victory Medal (Inter-Allied War Medal).
