

LEWIS. P.



Seaman-Gunner Philip Lewis, Number 1213x, having no known last resting-place, is commemorated on a bronze beneath the Caribou at the Newfoundland Memorial Park at Beaumont-Hamel.

Philip Lewis, fisherman, having *answered the call* of the Naval Authorities for volunteers, travelled to St. John's, capital city of the Dominion of Newfoundland where, on September 5 of 1914, having arrived from the District of Bay de Verde, he reported...*to duty*...on the Naval Reserve training ship, HMS *Calypso*, moored in the harbour (see below).

On that same September 5 Philip Lewis enlisted for the first time into the Reserve (see further below), was signed on to undertake a five-year term of service with the Royal Naval Reserve and underwent a satisfactory medical assessment on the same day. He subsequently also began a twenty-eight day of training which was to conclude on October 3.

Philip Lewis was also likely to have attested at this time, pledging his allegiance to the King-Emperor, George V.



**(Right: At the outset of their career, the ‘Calypso-Class’ ships were apparently considered to be superior vessels. Hybrids - powered by both steam and sail - they were able to police the outer reaches of the British Empire most efficiently and economically. The rapid progress in engine technology, however, was to mean that HMS ‘Calypso’ and her sister-ships would soon be out-classed by newer vessels. – This Royal Navy photograph, taken before 1902 when the drill-hall was reportedly built on her upper deck and the funnel removed, is from Wikipedia)**



**\*In the early days of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist. Later recruits – as of or about May of 1916 - signed on for the ‘Duration’ at the time of their original enlistment.**



**(Right above: The White Ensign has been flown by the Royal Navy in its present form since about the year 1800 although other naval ensigns had existed for at least two centuries. It consists of a red St. George's Cross – the national flag of England - on a white field with the Union Flag\* in the upper canton.)**

**\*The Union Flag is commonly referred to as the ‘Union Jack’; this is, in fact, a misnomer since a flag is referred to as a ‘Jack’ only when flown from the bow of a ship.**

**Note: During the years preceding the Great War the only military force on the Island of Newfoundland – apart from a handful of ill-fated local attempts – was to be the Royal Naval Reserve (Newfoundland). Even so, it was to be some thirty years after the withdrawal of British troops from the Dominion in 1870 before the Reserve came into being in 1902.**



**Just fewer than four-hundred men were sought to enroll as seamen – apparently automatically at the rank of Able Seaman - and to present themselves annually in St. John's for five years in order to train for a period of twenty-eight days per annum. Allowed to report at a time of their own choosing, it is perhaps not surprising that these volunteers**

– mostly fishermen – were to opt to train during the winter months when fishing work was minimal.

*Expenses were apparently defrayed for the most part by the British (Imperial) Government and an attempt was made to ensure the number of recruits would be kept constantly at a maximum. This practice and policy was then to be continued up until the onset of hostilities some twelve years later.*

*Of course, the purpose of having a reserve force at any time is to provide a trained force ready at any time to serve at a time of need or crisis. Thus in August of 1914, upon the Declaration of War by the government in London, hundreds of those men of the Royal Naval Reserve (Newfoundland) were to make their way to St. John's, from there to take passage overseas to bolster the ranks of the Royal Navy.*




A branch of the senior service from Britain's oldest colony. Naval reservists before leaving Newfoundland to serve in the Empire's cause.

*An elderly vessel, HMS 'Calypso', having become surplus to the Admiralty's needs, had been provided to the Dominion of Newfoundland by the Royal Navy in 1902 for training purposes. After some debate it was eventually decided that she would be permanently moored in the harbour of the capital, her superstructure reduced, and a wooden shelter built on her upper deck to provide training facilities and living quarters for the prospective naval recruits.*

Following the regulation twenty-eight days of training\* spent in St. John's, Seaman Lewis, promoted by this time from the rank of seaman recruit and one of a draft of three-hundred nine Naval Reservists and officers, embarked on November 5-6 onto the *Cunard* ocean-liner *Franconia* which had arrived in St. John's having sailed from New York on its trans-Atlantic way to Liverpool.

*\*It appears that in many cases, even if the recruit in question had not already previously been with the Royal Naval Reserve, the required twenty-eight day training period, all or partially, was waived by 'Royal Proclamation'.*

*(Preceding page: A relatively new vessel, the 'Franconia' had been launched on July 23 of 1910. Remaining un-requisitioned as a troop transport until early 1915, it was to be well over a year later that on 4 October, 1916, while heading for Salonika, she was torpedoed and sunk by a German U-boat to the east of Malta She was not carrying any troops at the time, but out of her 314 crew members, 12 died. – the photograph is from Wikipedia)*

Their ship then having docked in the English port-city of Liverpool on November 12, several of the Reservists were posted directly to a ship. Others were ordered to undergo further training at various Royal Navy establishments and, likely having journeyed by train, reported to these bases on or about November 13.

Thus, likely on the aforementioned November 13, Seaman Lewis was...*taken on strength...*at HMS *Excellent*, the Royal Navy Gunnery School located on *Whale Island* at the entrance to the harbour at Portsmouth. He was to train there until December 11 when he was ordered to join his ship, HMS *Viknor*, likely destined to man one of the guns with which by that time the ship had been fitted.





The Armed Merchant Cruiser *Viknor* was an elderly ship, obsolete and apparently under-powered with a top speed of only fourteen knots. In her earlier lives she had firstly been, as of 1888, the SS *Atrato*, before then having been re-named as the SS *Viking* in 1912. Upon the outbreak of the *Great War* in 1914 she had been requisitioned by the British Admiralty and baptized on a third occasion as HMS *Viknor*.

At the time of Seaman-Gunner Lewis' transfer to *Viknor*, the ship was apparently at the time based on the River Tyne in north-east England. She was not to leave port until December 28 and not to join her squadron (see below) until January 1.

'*Viknor*' was to be attached to the 10<sup>th</sup> Cruiser Squadron, also known as the *Northern Patrol*, a force originally having comprised out-of-date warships which, unable to cope with the harsh elements, by that January of 1915 had been replaced by requisitioned ocean-going passenger-liners carrying a few guns as old as the sometimes venerable ships on which they were mounted.

The ships of the 10<sup>th</sup> Cruiser Squadron were not spoiling for a fight. Their job was to form a part of the naval blockade designed to prevent ships carrying goods to Germany from reaching their destination; to accomplish this these vessels had to patrol the area of stormy waters encompassed by Ireland, northern Scotland and Iceland, a thankless job at the best of times: during the tempestuous winter months, even worse.

In early January the ships of the *Northern Patrol* stopped a Norwegian vessel, the *Bergensfjord*, and transferred a number of persons, one of them a suspected spy, to *Viknor*, she then being ordered to proceed to Liverpool.

From what is known about *Viknor*, she was hardly a vessel fit for the task at hand and January and February of 1915 were to apparently be particularly stormy. What is more, a German counterpart, the steamship *Berlin*, had recently been reported in the area sowing mines – one of which had already sunk the British battleship *Audacious* some three months before – and other ships since.

It still remains a bit of a mystery as to what happened to *Viknor* although it appears to be that either she fell victim to the bad weather or that she was sunk by a mine. All that may be said with any great certainty is that there was not to be a single survivor: of the crew of three-hundred two, including twenty-five of the Royal Naval Reserve (Newfoundland), all were to perish\*.

*\*Her wreck was found off the coast of County Donegal, Ireland, in the year 2006, but no firm conclusion was to come about as to the cause of the ship's sinking.*

The son of Frederick Lewis (also found as *Louis*), fisherman, seaman and labourer, and of Melina Ann Lewis (also found as *Selina*, née *Froud*\*) of the Conception Bay community of Pascoe Plain(s) in the Parish of Lower Island Cove, he was also brother to Eli, Amelia-Ann, Simeon, Phœbe and to Samuel-Wesley.


*\*Her story based upon incomplete files appears to have been a convoluted one: she is recorded as having given birth to a daughter, Jane, out of wedlock on June 22, 1881. Then on May 4, 1884, she, by then the wife of a Stephen Emberley, gave birth to daughter Sarah, followed in May(?) of 1886 by Melina junior.*

*On April 19, 1887, she, widow Melina Ann Emberley, married Frederick Lewis with whom over the course of several years she parented six children – one of whom was Philip, the only one for whom –Alas! - there appear to be no available records. Once again widowed, she married Samuel Reynolds on May 15, 1914.*

*She passed away in 1945, aged 83 years.*

*All of the above conclusions obviously appear to be correct from the sources which are to be found. However there exist many voids and even contradictions which may open everything – particularly pertaining to Philip Lewis: to be questioned.*

Seaman-Gunner Philip Lewis died on January 13, 1915, at an *un-recorded* age: however, the date of his birth in Lower Island Cove is documented on his enlistment papers as having been May 10 of 1895.

*Seaman Lewis served only in the Royal Navy and was not in the service of Canada as is cited in some sources, notably the Commonwealth War Graves Commission.*

Seaman-Gunner Philip Lewis was entitled to the 1914-1915 Star, the British War Medal (centre) and to the Victory Medal (Inter-Allied War Medal).
