

Private Robert Meadus (Regimental Number 1013), having no known last resting-place, is commemorated on the bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.



His occupation previous to military service recorded as that of a baker employed by *Harvey's Bakery* and earning a weekly five dollars, Robert Meadus presented himself for medical examination at the *Church Lads Brigade Armoury* on Harvey Road in St. John's, capital city of the Dominion of Newfoundland, on January 28 of the year 1915. It was a procedure which was to pronounce him as...*Fit for Foreign Service*.

It was to be just a single day following his medical assessment, on January 29, that Robert Meadus returned to the *CLB Armoury* to enlist – engaged at the private soldier's rate of a single dollar per diem plus a daily ten-cent *Field Allowance*.

However, whereas attestation for others had come about on the day of enlistment, he was now to await a further two weeks less a day, until February 11, before *that* final formality would come to pass.

For Private Meadus, Number 1013, there was now to be yet another, and last, waiting period of five weeks plus two days before he would be summoned to...*overseas service*. How he occupied himself during that time is not recorded among his papers; he may, of course, have temporarily returned to work, but this is only speculation.

Unlike the two previous contingents to have departed Newfoundland (see below) for...overseas service, Private Meadus' 'D' Company was not to sail directly to the United Kingdom. On March 20, it embarked onto the Bowring-Brothers' vessel Stephano for the short voyage to Halifax, capital city of the Canadian province of Nova Scotia, where it was thereupon to board a second vessel, the newly-launched Orduña for the trans-Atlantic crossing\*.

Having then sailed from Nova Scotia on March 22 for Liverpool, Private Meadus and his draft landed there eight days later, on the 30<sup>th</sup>. Once disembarked in Liverpool, the twohundred fifty men and officers of 'D' Company were thereupon transported on the same date by train directly to Edinburgh, the Scottish capital, to join the Newfoundland Regiment's 'A', 'B' and 'C' Companies.

These units were by this time stationed at the historic Castle, 'A' and 'B' having recently been posted from Fort George and 'C' having arrived directly from home (see further below). After 'D' Company's arrival at the end of that month of March, the Newfoundlanders were now to remain at Edinburgh for the following six weeks.

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

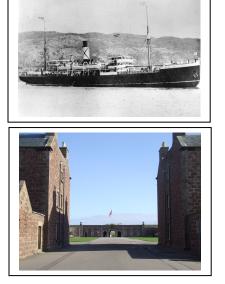
This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern





England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 'C' Company – the first re-enforcements for the original contingent\* - would arrive directly from Newfoundland.

\*This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.

As seen in a previous paragraph, for the month of April and the first days of May of 1915, 'A', 'B', 'C' and 'D' Companies, now united, were to furnish the garrison – the first troops from outside the British Isles to do so - of the guardian of Scotland's capital city. Then, during the first week of May, 'E' Company was to report there...*to duty*...from home. Four days later again, on May 11, the Newfoundland contingent was ordered elsewhere.

On that day, three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. The now-formed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus rendered available to be sent on 'active service'.

\*This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming  $2^{nd}$  (*Reserve*) Battalion.

It was while the Newfoundland Battalion was in training during those weeks at Aldershot, on August 15, that Private Meadus would be prevailed upon to enlist for the...*duration of the conflict.* 

\*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.

However, for some apparently unrecorded reason, Private Meadus, although present at Aldershot with 'D' Company, was not to sail to the Middle East. He returned north and was attached to the new Regimental Depot instead.

At the end of the summer of 1915, the once-Royal Borough of Ayr on Scotland's west coast was to begin to serve as the overseas base for the  $2^{nd}$  (*Reserve*) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the  $1^{st}$  Battalion's numbers, at first to the Middle East and then later to the *Western Front*.

It was not to be until November 14 of that autumn of 1915 that Private Meadus passed through the English south-coast naval establishment of Devonport as a soldier of the 1<sup>st</sup> Reenforcement Draft from Ayr and embarked on the troopship *Olympic*, sister-ship of *Britannic* and the ill-fated *Titanic*. Private Meadus arrived at *Suvla Bay* on December 1 via Mudros on the Greek island of Lemnos.







Only three weeks later the British were to abandon the Suvla Bay adventure.

In the meantime, of course, the 1<sup>st</sup> Battalion of the Newfoundland Regiment had already travelled from England to the Middle East for service with the 29<sup>th</sup> Division in the ongoing *Gallipoli Campaign*.

On August 20, 1915, the Newfoundland Battalion had embarked in the Royal Navy Harbour of Devonport on England's south coast onto the requisitioned passenger-liner *Megantic* for passage to the eastern end of the Mediterranean Sea and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion was to land on *Kangaroo Beach* at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders had landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had been proving to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.

November 26 of 1915 would see perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There had been many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, had been those afflicted by trench-foot and by frostbite.

Such was the situation into which the 1<sup>st</sup> Re-enforcement Draft from Ayr – Private Meadus among its ranks – had set foot on that December 1 of 1915.

During the days that followed that aforementioned debarkation, the British positions at *Suvla Bay* were to become yet more and more untenable and thus on the night of December 19-20, the area was abandoned – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.

Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case was the respite to be of a long duration; the Newfoundland Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – were by then only marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation took place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

\*Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.

Immediately after the British evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15<sup>th</sup> of that month. The Newfoundlanders would then on the morrow be transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division was yet to be decided\*.

\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.

During this period served at Suez, on February 12, Private Meadus was admitted into the 17<sup>th</sup> Stationary Hospital at Port Tewfiq suffering from jaundice and, five days later, was transferred to the British Red Cross Hospital at Giza – where the pyramids and sphinx stand - on the outskirts of Cairo.

He was discharged from there...to duty...to the Base Depot, Mustapha, in the vicinity of the port-city of Alexandria on the 29<sup>th</sup> of March.

How and exactly when Private Meadus journeyed to re-join the 1<sup>st</sup> Battalion – it had disembarked in France on March 22 – is apparently not recorded in his personal files – but it was almost certainly by ship from either Alexandria or from Port Saïd via Marseilles and then from there by train to the British Expeditionary Force Base Depot at Rouen.

There he would have awaited the arrival of a re-enforcement draft from Ayr which to accompany to seek out the parent unit by then stationed on the Western Front.

Private Meadus returned to his unit on May 9, one of a draft from Rouen of twelve other ranks and an officer which arrived on that date from Rouen while the Newfoundlanders were out of the trenches and billeted in the village of Louvencourt.

After the departure of Private Meadus for medical attention and also after the remainder of that two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1<sup>st</sup> Battalion boarded His Majesty's Transport Alaunia at Port Tewfiq, on March 14 to begin the voyage through the Suez Canal en route to France.

The Newfoundlanders would disembark eight days afterwards in the Mediterranean portcity of Marseilles, on March 22.

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1<sup>st</sup> Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

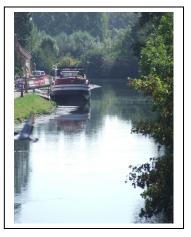
\*It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.







And, as recorded in a previous paragraph, it was during these weeks of preparation and anticipation, at a time when the 1<sup>st</sup> Battalion was billeted in the community of Louvencourt, that Private Meadus, as a soldier of a re-enforcement draft from Scotland via Rouen, re-joined the parent unit on May 9.

There were now just over seven weeks to wait before the British summer offensive was to commence.

\* \* \* \* \*

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.

There are other numbers of course: the fiftyseven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action* or *died of wounds*.

It was to be the largest disaster *ever* in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for the next four and a half months.

\*In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

The son of Henry Meadus, *also* a baker with *A. Harvey* & Co., deceased February 7, 1920, and of Susanna Meadus (née *Low*(?)) – to whom he had allotted a daily allowance of sixty cents from his pay - of 26, Scott Street, St. John's, he was one of nine children: Monica; Cecil-James; Allan-George; Frederick - to whom he willed his all; Mrs. Leonard(?) Knight – was she sister Ethel-May?; Fiona(?); Maggie and Annie\*.

\*Some of this family information requires confirmation. However, if correct, the couple, Henry and Susannah, married in Trinity on May 19, 1890.

Private Meadus was at first reported as *missing in action* at Beaumont-Hamel on July 1, 1916, while serving with 'B' Company during the fighting of the first day of *the Somme*.

However, this record was amended so as to read *killed in action* subsequent to a letter submitted on August 29, 1916, by the Officer Commanding the  $71^{st}$  Infantry Brigade.

Robert Meadus had enlisted at a *declared* twenty years of age: date of birth in St. John's, Newfoundland, December 8, 1895 (from the Newfoundland Birth Register).

Private Robert Meadus was entitled to the 1914-1915 Star, as well as to the British War Medal (centre) and to the Victory Medal (Inter-Allied War Medal).
