

I am directed to acknowledge receipt of your letter of 11th Feb. dealing with the matter of pay on account of No. 2056, Private Luke Hugford.

I will explain that, when a soldier is leaving and makes all alletment to a dependent, it is done at his own volition. If a soldier is killed in action, or has died of wounds, his pay ceases. Where an alletment has been payable to a dependent, the matter is referred to the Pensions Board, who decide whether or not the dependent is to be paid any pension. If the claim for pension is allowed, this Deppt. is requested to centime payment of alletment on account of any pension that might subsequently be granted.

The \$18.00 per menth has been continued to you under this arrangement. And when the Pension Commissioners have been appointed by the Hovernment, these payments of allotment will cease, and payments will be hadd in full from the pension at the disposal of the Pension Commissioners.

I trust this explanation is estimatory, and I should be glad to give any durther information if you will address a letter to this Department to the law of the con-

Though he has laid down the earthly weapons of warfare, he now wears the Soldier's Crown of Victory, and his name will be inscribed upon the Glerious Rell of Heneur, and be held in fragrant memory by all his fellow-countrymen. When the victory is won and Peace again reigns upon the earth, it will be a comforting thought to you that in this glorious achievement he bore no small part.
