



Lance Corporal George Edward (elsewhere found as Edmund) Pike (Regimental Number 898) is interred in Y Ravine Cemetery – Grave reference D. 108. He shares a grave marker with a private of the Border Regiment.

His occupation previous to military service recorded as being that of a *salesman* earning a yearly three-hundred dollars, George Edward Pike presented himself for medical examination at the *Church Lads Brigade Armoury* on Harvey Road in St. John's, capital city of the Dominion of Newfoundland on the tenth day of December of 1914. It was a procedure which was to pronounce him as...*Fit for Foreign Service*.

It was to be a further twenty-five days following this medical assessment, on January 4, before George Edward Pike returned to the *C.L.B. Armoury* to thereupon be enlisted – engaged at the private soldier’s rate of a single dollar per diem plus a daily ten-cent *Field Allowance*.

However, whereas attestation for others had come about on the day of enlistment, he was now to await a further day, until the morrow, January 5. before *that* final formality would come to pass.

Now for Private Pike, Number 898, there was now still yet to be a nine-week waiting period. How he occupied himself during that time is not recorded among his papers; he may, of course, have temporarily returned to work but this is only speculation.

Unlike the two previous contingents to have departed Newfoundland (see below) for...overseas service, Private Pike’s ‘D’ Company was not to sail directly to the United Kingdom. On March 20, it embarked onto the Bowring-Brothers’ vessel *Stephano* for the short voyage to Halifax, capital city of the Canadian province of Nova Scotia, where it was thereupon to board a second vessel, the newly-launched *Orduña* for the trans-Atlantic crossing*.

Having then sailed from Nova Scotia on March 22 for Liverpool, Private Pike and his draft landed there eight days later, on the 30th. Once disembarked in Liverpool, the two-hundred fifty men and officers of ‘D’ Company were thereupon transported on the same date by train directly to Edinburgh, the Scottish capital, to join the Newfoundland Regiment’s ‘A’, ‘B’ and ‘C’ Companies.

These units were by this time stationed at the historic Castle, ‘A’ and ‘B’ having recently been posted from Fort George and ‘C’ having arrived directly from home (see further below). After ‘D’ Company’s arrival at the end of that month of March, the Newfoundlanders were now to remain at Edinburgh for the following six weeks.

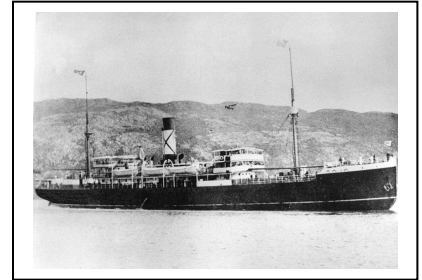

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.



The ship had sailed for the United Kingdom on the morrow, October 4, to rendezvous with the convoy carrying the 1st Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 'C' Company – the first re-enforcements for the original contingent* - would arrive directly from Newfoundland.

**This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.*

* * * * *

As seen in a previous paragraph, for the month of April and the first days of May of 1915, 'A', 'B', 'C' and 'D' Companies, now united, were to furnish the garrison – the first troops from outside the British Isles to do so - of the guardian of Scotland's capital city. Then, during the first week of May, 'E' Company was to report there...*to duty*...from home. Four days later again, on May 11, the Newfoundland contingent was ordered elsewhere.

On that day, three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

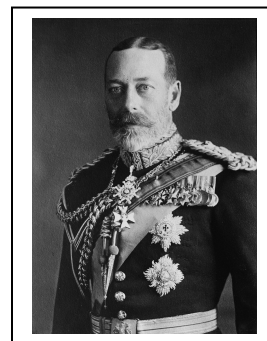
It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – ‘F’ Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength*. The now-formed 1st Battalion of the Newfoundland Regiment was thus rendered available to be sent on ‘active service’.

**This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.*

At the beginning of that August of 1915, the four senior Companies, ‘A’, ‘B’, ‘C’ and ‘D’, were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot. This force, now the 1st Battalion of the Newfoundland Regiment, was thereupon attached to the 88th Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force.



Meanwhile the two junior Companies, ‘E’ – last arrived at Edinburgh - and the aforementioned ‘F’, were ordered transferred to Scotland’s west coast, to Ayr, there to provide the nucleus of the newly-forming 2nd (Reserve) Battalion.

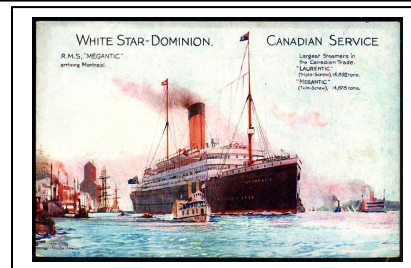

It was while the Newfoundland Battalion was in training during those weeks at Aldershot, on August 15 that Private Pike would be prevailed upon to enlist for the duration of the conflict.

**At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.*

On August 20, 1915, Private Pike and his Newfoundland unit embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1st Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, was proving to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

**Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.*

But it was also during this period while stationed at *Suvla Bay* that Private Pike received a first promotion, to the rank of lance corporal, on October 15.

During that short three-month period things were to worsen at *Gallipoli** for the British in general and for the 1st Battalion of the Newfoundland Regiment in particular.

**The French know the place as ‘Les Dardanelles’ while the Turks call it ‘Çanakkale’.*

November 26 of 1915 would see perhaps the nadir of the Newfoundland Battalion’s fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

* * * * *

It was on that same November 26, on the day of the freak rain-snow-and-ice storm that struck the *Suvla Bay* area, that Lance Corporal Pike was evacuated into the 54th Casualty Clearing Station there, to be diagnosed as suffering from jaundice. Sixteen days later, by December 12, he had been transferred to the 3rd Canadian Stationary Hospital at Mudros, on the Greek Island of Lemnos – a second report has him already on the island by November 30.

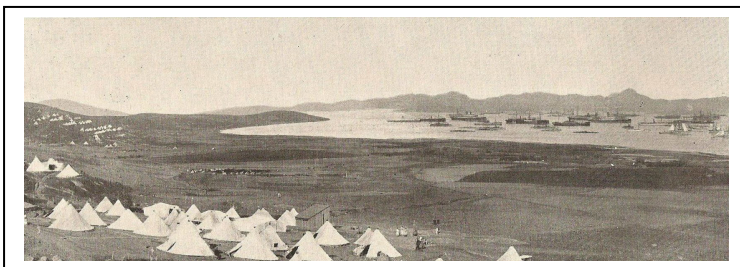


**No Canadian troops were to serve in the Gallipoli Campaign, the 3rd Stationary Hospital being perhaps the only Canadian presence in the eastern Mediterranean during this period. The hospital’s matron and a nursing sister also lie in Portianos Cemetery, victims of dysentery.*

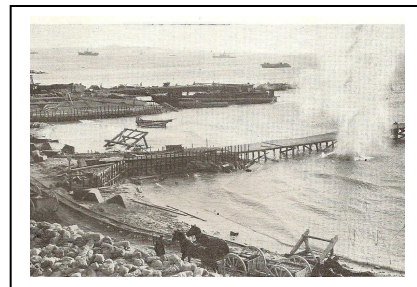
Lance Corporal Pike was discharged into the Lowland Convalescent Camp, also at Mudros, on December 17. From there he was released *to duty* to the British Sidi Bishr Base Depot back in Alexandria, Egypt, on the penultimate day of 1915, December 30. Some two weeks later again, on January 16, he reported *to duty* with the 1st Battalion, the Newfoundland unit by then having returned from the island of Imros and from the Gallipoli Peninsula.

* * * * *

In the meantime, at *Suvla Bay* during the first days after Lance Corporal Pike's departure for medical attention, the British positions had been becoming more and more untenable and thus on the night of December 19-20, the area had been abandoned – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.



Some of the Battalion personnel were to be evacuated to the nearby island of Imbros, some to Lemnos, further away; but in neither case was the respite to be of a long duration; the 1st Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had been by then only marking time until a complete withdrawal of the *Peninsula* could be undertaken.



This final operation had taken place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

**Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.*

Immediately after the British had evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of Alexandria, to arrive there on the 15th of that month. The Newfoundlanders had then immediately been transferred southward to the vicinity of Suez, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29th Division had yet to be decided*.



**Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.*

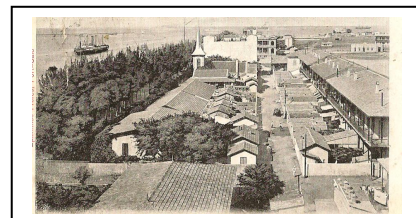
And it was to be at this time, as recorded in an earlier paragraph, that Lance Corporal Pike had re-joined the Newfoundland Battalion on January 16 to travel with it southwards to its encampment in the vicinity of Suez.

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and *other ranks* of the 1st Battalion boarded His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage up through the *Suez Canal* en route to France.



During the latter part of February of 1915, on the 27th, Private Pike was admitted into the 18th Stationary Hospital, established at the time in the vicinity of Cairo. He was there to receive treatment for myopia, care that was to last for only two days, until the 29th when he was discharged back *to duty* with the Newfoundland Battalion.

The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseilles, on March 22.

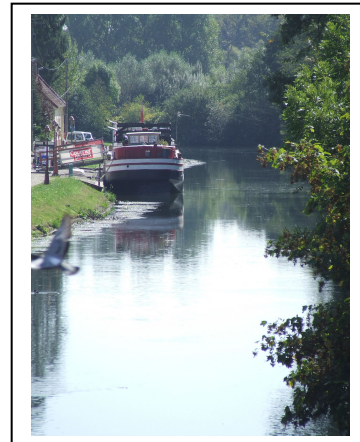

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1st Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

**It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2nd Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.

**Perhaps ironically, the majority of the Battalion’s casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action or died of wounds*.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man’s-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.



The son of Nathaniel Pike, employee of *His Majesty’s Customs* - to whom his son had willed his all and to whom he had also allotted a daily allowance of seventy cents from his pay - and of Emma Pike (née *Parsons*, deceased in 1907), latterly of 7, Bell Street, Grand Falls*, he was also brother to Susie, Ralph, Paul-Hayward, Alexander-Parsons, Lorenzo-

Hall, Ronald-Taylor, Chesley-Arguin, Howard-Douglas, John-Charles, William-Henry and to Morley-Goodison, all offspring of their father's first marriage**.

**The family had originally come from Harbour Grace, where George Edmund was born.*

Lance Corporal Pike was reported as *missing in action* at Beaumont-Hamel on July 1, 1916. He had been serving with 'D' Company during the fighting of the first day of *the Somme*. Six months later, on December 31, he was officially *presumed dead*.

However, a subsequent report submitted by the Officer Commanding 3rd Army Mobile Graves Registration Unit documented the identification and burial of his remains on June 17, 1917. Lance Corporal Pike's record was thus amended so as to read *killed in action 1/7/16*.



George Edward Pike had enlisted at a *declared* thirty-one years of age: date of birth in Harbour Grace, Newfoundland, November 28, 1883 (from the Newfoundland Birth Register - as is the name *Edward*).
