



Private James Joseph Pike (Regimental Number 1220), having no known last resting-place, is commemorated on the bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.



His occupation previous to his military service recorded as that of a *sailor* working for a monthly twenty dollars, James Joseph Pike presented himself for medical examination at the *Church Lads Brigade Armoury* in St. John's, capital city of the Dominion of Newfoundland, on January 22, 1915. It was a procedure which would pronounce him as being...*Fit for Foreign Service*.


It was now to be seven weeks following that medical assessment before he returned to the *CLB Armoury* on Harvey Road on March 12, on this occasion to enlist – engaged at the private soldier's rate of a single dollar per diem plus a daily ten-cent *Field Allowance*. There appears to be no reason for the delay cited in the records although it is not impossible that he were out at sea during that period

Two weeks less a day after his enlistment, on March 25, he would undertake his attestation, to swear his *Oath of Allegiance*, the concluding official formality. At that moment James Joseph Pike thereupon became...*a soldier of the King*.

There now passed a further lengthy period of four weeks before, on April 22 of 1915, Private Pike, Number 1220, embarked in the harbour at St. John's for...*overseas service*...with the two-hundred forty-nine officers and...*other ranks*...of 'E' Company onto the Bowring Brothers' vessel *Stephano* en route for Halifax.

No details appear of how or where he may have spent that intervening four-week period before taking ship for...*overseas*: he may have returned home to Avondale - perhaps even temporarily to work – but this is mere speculation.


Having left St. John's, on April 24 at eleven-thirty in the evening, the detachment began its trans-Atlantic passage on board the trans-Atlantic liner *SS Missanabie* from Nova Scotia to Liverpool. The vessel arrived in that English west-coast port-city on May 2 or 3 – the two dates are recorded although the second may well have been the date of disembarkation.



The Newfoundlanders on this occasion had sailed from Halifax in the company of the Canadian Army Service Corps *Railway Supply Depot*.



From Liverpool the contingent travelled northwards by train to the Scottish capital, Edinburgh where, on May 4, 'E' Company joined 'A', 'B', 'C' and 'D' Companies which had already taken up station as the garrison at the historic Castle, the first troops from outside the British Isles ever to do so.




Private Pike's 'E' Company, however, was to have but a few days to savour the charms of the Scottish capital.

\* \* \* \* \*

Some seven months before that May 4, in the late summer and early autumn of 1914 there had been a period of training of five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

Once having disembarked in the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the *Salisbury Plain*; then in Scotland at *Fort George* – on the *Moray Firth* close to Inverness; and lastly at *Edinburgh Castle* – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after ‘A’ and ‘B’ Companies had taken up their posting there, on February 16 of 1915, ‘C’ Company – the first re-enforcements for the original contingent\* - would arrive directly – through Liverpool of course - from Newfoundland. On the final day of the month of March it had been the turn of ‘D’ Company to arrive – they via Halifax as well as Liverpool – to report...*to duty*...at Edinburgh.

*\*This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.*

\* \* \* \* \*

Seven days after the arrival of Private Pike’s ‘E’ Company in the Scottish capital, on May 11 the entire Newfoundland contingent was ordered elsewhere.

On that day, seven weeks into spring – although in Scotland there was apparently still snow - the unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – ‘F’ Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. On that date the newly-formed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus now available to be ordered on...*active service*.

*\*This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.*

At the beginning of that August of 1915, the four senior Companies, ‘A’, ‘B’, ‘C’ and ‘D’, were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at *Camp Aldershot*. This force, now the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – as seen, the last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming 2<sup>nd</sup> (Reserve) Battalion.

The Depot was to be Private Pike's home for the next three months.

At the end of this summer of 1915, the once-Royal Borough of Ayr on Scotland's west coast was to begin to serve as the overseas base for the 2<sup>nd</sup> (Reserve) Battalion of the Newfoundland Regiment from where – as of November of 1915 and up until January of 1918 - re-enforcement drafts from home were to be despatched to bolster the 1<sup>st</sup> Battalion's numbers, at first to the Middle East and then later to the *Western Front*.



Private Pike had enlisted for the limited time of a single year. Most of his fellow recruits during the time spent at Ayr were prevailed upon to re-enlist. and while in the case of Private Pike this event does not appear among his documents, it is quite possible this was where and when it came about\* – as it surely must have done: Recruits who did not re-enlist were to be on their way home before the...*First Battle of the Somme*.

*\*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist. Later recruits signed on for the 'Duration' at the time of their enlistment.*

It was not until the fourteenth – some sources cite the thirteenth - day of November of 1915 that the 1<sup>st</sup> Re-enforcement Draft from Ayr – Private Pike among its ranks - passed through the English south-coast naval establishment of Devonport to embark onto His Majesty's Transport *Olympic*, sister ship of the ill-fated *Titanic* and of the almost equally ill-fated *Britannic* – that ship to be sunk in November of 1916.



The 1<sup>st</sup> Draft was en route to *Gallipoli*.


**At the end of the month, *Olympic* entered *Mudros Bay* on the Greek island of Lemnos, the site being used - since it was only some fifty kilometres distant from the fighting - by the Allies as an advanced base and medical complex for the *Gallipoli Campaign*.**

**The one-hundred Newfoundland re-enforcements were subsequently embarked onto a smaller vessel for the journey to *Suvla Bay* on the northern coast of the Peninsula. There they were to land on a rocky surface – in contrast to the sand of the other landing areas - designated as...*Kangaroo Beach*.**

**From there the newcomers would move forward to the not-distant Newfoundland positions.**



**In the mean-time, while Private Pike was accustoming himself to life at the new Regimental Depot in Scotland, the officers and men of the 1<sup>st</sup> Battalion of the Newfoundland Regiment at Camp Aldershot were preparing themselves for the voyage to the other end of the Mediterranean Sea.**




**On August 20, 1915, the Newfoundland Battalion had embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.**

**When the Newfoundlanders had landed from their transport ship at Suvla Bay on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.**

**Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire Gallipoli Campaign, including the operation at Suvla Bay, had been proving to be little more than a debacle:**

**Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of their allies, the French, and it would finally be decided to abandon not only Suvla Bay but the entire Gallipoli venture.**



**\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.**

November 26 of 1915 had seen perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, had been those afflicted by trench-foot and by frost-bite.

This then had been the situation into which the one-hundred re-enforcements of the 1<sup>st</sup> Draft from Scotland were to step when they had set foot on the sand and stone – mostly the latter – of *Kangaroo Beach* on December 1 of 1915.

\* \* \* \* \*

In the days following the dis-embarkation of Private Pike with the 1<sup>st</sup> Re-enforcement Draft, the situation of the British - and thus of the Newfoundlanders - was daily becoming more and more untenable; thus on the night of December 19-20, the British had abandoned the entire area of *Suvla Bay* – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard. Some of the Battalion personnel had been evacuated to the nearby island of *Imbros*, some to *Lemnos*, further away, but in neither case was the respite to be of a long duration; the 1<sup>st</sup> Battalion was to be transferred only two days later to the area of *Cape Helles*, on the western tip of the...*Gallipoli Peninsula*.

The British, Indian and *Anzac* forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had now only been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation would take place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

**Immediately after the British evacuation of the Gallipoli Peninsula, the Newfoundland unit had been ordered to the Egyptian port-city of Alexandria. On January 14, the Australian Expeditionary Force Transport Nestor had arrived there with the 1<sup>st</sup> Battalion on board. The vessel was to sail just after mid-day on the 16<sup>th</sup>, on its way southwards down the Suez Canal to Port Suez where she arrived on the morrow and where the Newfoundlanders landed and marched to their encampment.**



**There they were to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division had yet to be decided\*.**


**\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was already becoming a theatre of war.**

**On February 14, Private Pike was evacuated from the encampment at Suez and admitted into the British Red Cross Hospital at Cairo, diagnosed as suffering with enteric (typhoid) fever. He was discharged from there on March 8, apparently too late to join the Newfoundland Battalion which was due to sail for France from Port Tewfiq at the southern end of the Suez Canal on March 14.**


Thus on March 18, Private Pike – having likely spent that interim of a few days at the Base Depot in Alexandria - took ship at Port Saïd at the *northern* end of the Canal and set sail for the French Mediterranean port of Marseilles on His Majesty’s Transport *Lake Manitoba*. There he arrived on March 26, four days following the disembarkation of the 1<sup>st</sup> Battalion on the 22<sup>nd</sup>.



He was not to be the only Newfoundlander to have done so (see below).

(Right: *The Canadian Pacific Railway liner ‘Lake Manitoba’ was a passenger ship of the ‘Beaver Line which as of 1901 was to sail between Liverpool and Montreal in the summer and between Liverpool and Halifax in the winter when the St. Lawrence was closed. On August 4 of 1914, the day that Britain declared War, she was requisitioned for use as a troop transport during the war. Four years later, on August 26, 1918, she caught fire and was scuttled. Having been re-floated and re-fitted, she resumed the Atlantic service as a cargo ship.*)



Private Pike disembarked from *Lake Manitoba* in the French Mediterranean port of Marseille on March 26 – only four days after the Newfoundland Battalion had done so – but, being too late to join the parent unit there, he was transferred to the British Expeditionary Force Base Depot outside the Norman capital city of Rouen.

As related above, there had been a number of Newfoundland personnel who would take passage on the same vessel, many of them having served not in *Gallipoli* but in the transport section of three composite battalions in the area of the Egyptian western frontier. While Private Pike’s record does not document his return to the 1<sup>st</sup> Battalion, the records of some of these other men do just that: the likelihood is that Private Pike did as *they* did.

On April 15 a detachment from Rouen of two-hundred eleven...*other ranks* – accompanied by two officers – reported...*to duty*...with the 1<sup>st</sup> Battalion, it by that time already billeted in the village of Englebelmer, some three kilometres behind the lines of the *Western Front*. Most of the men arriving from Rouen were soldiers of the 3<sup>rd</sup> Re-enforcement Draft from the Regimental Depot at Ayr, but a number had been attached from elsewhere.

Almost certainly Private Pike was one of them.

\* \* \* \* \*

After that two-month interim spent in the vicinity of Port Suez the almost six-hundred officers and *other ranks* of the 1<sup>st</sup> Battalion were to board His Majesty’s Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage through the *Suez Canal* en route to France.

The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseille, on March 22.



Some three days after the unit’s disembarkation on March 22, the Newfoundland Battalion’s train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseille. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.

Having de-trained at the local station at two o’clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l’Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they had then marched on their way from the station. But some three months later *the Somme* was to become a part of their history.

On April 13, the 1<sup>st</sup> Battalion had subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days’ time, would be introduced into the communication trenches of the *Western Front*.

\* \* \* \* \*

On April 15, the day on which had arrived the aforementioned...*re-enforcements from Scotland via Rouen*...and those who had joined them there from Egypt, two of the four Companies – ‘A’, and ‘B’ – were to take over several support positions from a British unit\* before the entire Newfoundland unit was to then be ordered to move further up for the first time into forward positions on April 22.

*\*It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *la Somme*, that flowed – and still does so today – through the region.



If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

**\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.**

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action or died of wounds*.


It was to be the greatest disaster ever in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for four and a half months.

***In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man’s-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.***

**The son of Joseph Pike (former fisherman, deceased, perhaps May 13, 1901 of consumption) and of Winifred Pike (née Hogan, she claimed to be her son’s only surviving kin)\* – to whom he had allotted a daily allowance of fifty cents from his pay, of Tickle Harbour (today known as Bellevue), he appears to have had no siblings.**

***\*His mother then later appears to have married Daniel Moore on December 11, 1903, in St. John’s, the couple afterwards to live in Avondale. The Roman Catholic Parish Records there show a Daniel Moore and Winnifred Egan as parents to Anne-May, to Frederick, and to Patrick; the 1921 census appears to add Edward, Michael, Thomas and May-Joseph (this last possibly daughter of Joseph Pike)\*.***


***\*Additional confirmation or rebuttal of the above in italics would be appreciated.***

**Private Pike was at first reported as *missing in action* at Beaumont-Hamel on July 1, 1916, while serving with ‘A’ Company during the fighting of the first day of *the Somme*. Some six months later, on December 31, he was officially *presumed dead*.**

**James Joseph Pike had enlisted at a *declared* nineteen years of age: date of birth at Tickle Harbour, Trinity Bay (*Bellevue*), October 2, 1897 (from the Newfoundland Birth Register and also found on the Pike Family web-site\*).**

***\*The same source records the date of Winnifred Hogan’s marriage to Joseph Pike in Bellevue as March 9, 1898.***
