



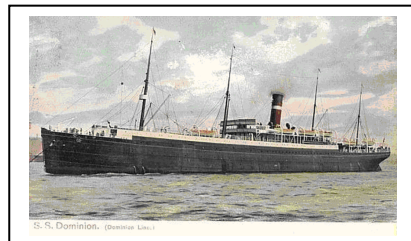
Private William Patrick Prowse (Regimental Number 925) lies in Etretat (also spelled *Étretat*) Churchyard – Grave reference II. D. 2.

His occupation previous to military service recorded as that of a *grocer* with a weekly income of nine dollars, William Patrick Prowse presented himself for medical examination on December 1, 1914, at the *Church Lads Brigade Armoury* on Harvey Road in St. John's, capital city of the Dominion of Newfoundland. It was a procedure which was to pronounce him as...*Fit for Foreign Service*.

Six weeks less a day after having undergone this medical assessment, on January 11 of the New Year, 1915, he was to return to the *C.L.B. Armoury*, there to enlist – engaged at the private soldier's daily rate of a single dollar a day plus a ten-cent *Field Allowance*. It was then to be a further ten days before his attestation, the last of the enlistment formalities, on January 21.

Now for Private Prowse, Number 925, there was to be yet another waiting period, this of two weeks, before he was summoned to...overseas service. How he occupied himself during that period is not recorded among his papers; he may, of course, have returned to work but this is only speculation.

On the fourth day of February of 1915, the first reinforcements – this was ‘C’ Company - for the Newfoundland contingent – it was not yet at battalion strength - which by this time was serving in Scotland (see further below), were to embark via the sealing tender *Neptune* onto the SS *Dominion* – the vessel having anchored to the south of St. John’s, off Bay Bulls, because of ice conditions.



The vessel was then to sail - and Private Prowse thus departed Newfoundland for overseas service - a day later again, on February 5, for trans-Atlantic passage to the United Kingdom.

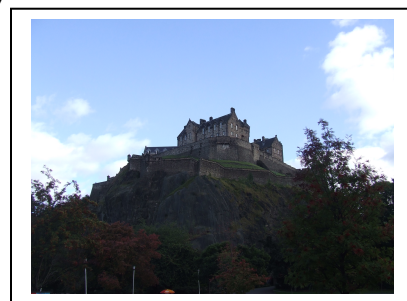

**There appears to be some confusion in some sources as to whether these troops were ‘C’ or ‘D’ Company. However, ‘D’ Company was to go overseas some time later on ‘Stephano’ to Halifax and then on ‘Orduña’ to Liverpool.*

Having disembarked in the English west-coast port-city of Liverpool, the Newfoundlanders entrained for Edinburgh, the first Newfoundland Regiment contingent having by this time been posted to the historic Castle in Scotland’s capital city. There they were to provide the garrison, thus being the first unit from overseas ever to do so.



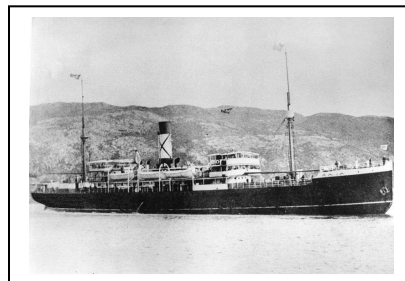
Private Prowse and the other new-comers reported to duty at Edinburgh Castle on February 16.

Five to six months before that time, in the late summer and early autumn of 1914 there had been a period of training of some five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John’s for the newly-formed Newfoundland Regiment’s first recruits - to become ‘A’ and ‘B’ Companies - during which time the authorities had also been preparing for the Regiment’s transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.



The ship would sail for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1st Canadian Division overseas, off the south coast of the Island.

In the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at *Fort George* – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles – and where 'C' Company and Private Prowse, as also cited beforehand, would arrive from Newfoundland on February 16 of 1915.

* * * * *

Some three months later, on May 11, and three weeks into spring – although in Scotland there was apparently still snow - the entire Newfoundland unit was ordered moved to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent received the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength*. The now-formed 1st Battalion of the Newfoundland Regiment was thus rendered eligible to be sent on 'active service'.

**This was approximately fifteen hundred, sufficient to furnish two re-enforcement companies and a headquarters staff.*

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as

an inspection by the King, at Aldershot. This force, now the 1st Battalion of the Newfoundland Regiment, was thereupon attached to the 88th Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force.

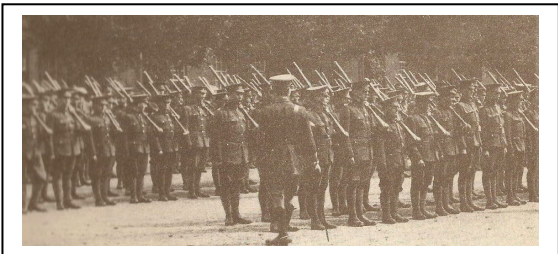
Meanwhile the two junior Companies, 'E' – last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming 2nd (Reserve) Battalion.

It was during this period at Aldershot, on August 15, that Private Prowse was prevailed upon to re-enlist, on this occasion for the duration of the war*.

*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.

On August 20, 1915, Private Prowse and the Newfoundland unit embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1st Battalion landed at *Suvla Bay* on the *Gallipoli Peninsula*.

When the Newfoundlanders landed from their transport ship at *Suvla Bay* on that September night of 1915 they were to disembark into a campaign that was already on the threshold of collapse.

Not only in the area where the Newfoundland Battalion was to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:



Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

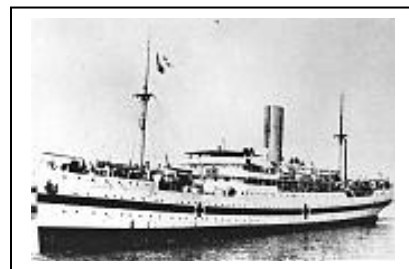
****Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.***

* * * * *

On November 6, Private Prowse was struck by a bullet in the left heel. Evacuated to the 54th Casualty Clearing Station at *Suvla Bay* on the following day, the 7th, from there he was subsequently transferred – possibly having passed through the Greek island of Lemnos - to the Military Hospital, Tigne, on the British-held Mediterranean island of Malta. There he arrived on the 13th on board His Majesty's Hospital Ship *Letitia*.

After having received medical attention in hospital – and by then having also additionally been diagnosed as afflicted with *catarrhal jaundice* - Private Prowse was eventually transferred to the *Mellieha Convalescent Camp*, also on Malta, on January 31 of the New Year, 1916.

Private Prowse was not to reach France until April 2, almost nine weeks later again, when he disembarked in the French Mediterranean port of Marseilles. No record of his travels during that period appears to have been documented among his personal files.

Private Prowse is then recorded as having reported *to duty* with the Newfoundland Battalion in the village of Louvencourt on the same day, April 8, as did the 2nd Re-enforcement Draft from Ayr, a detachment of two officers and one-hundred forty *other ranks* which had been ordered from the United Kingdom to Egypt, only to be immediately returned to France upon its arrival there, and which then landed in France the day after Private Prowse.

It may well be that Private Prowse joined this, the 2nd Re-enforcement Draft, in Marseilles – although, as the dates do not correspond, possibly having sailed on a different vessel from Egypt. However, there again seems to be no documentation in his dossier to either confirm or refute this eventuality.

* * * * *

In the meantime, during the short period which had then followed Private Prowse's evacuation from *Suvla Bay* for medical treatment, things were to worsen at *Gallipoli** for the British in general and for the 1st Battalion of the Newfoundland Regiment in particular.

November 26 of 1915 would see perhaps the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there had been a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, had been those afflicted by trench-foot and by frost-bite.

At *Suvla Bay*, the British positions had been becoming more and more untenable and thus on the night of December 19-20, the area had been abandoned – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.

Some of the Battalion personnel had been evacuated to the nearby island of *Imbros*, some to *Lemnos*, further away; but in neither case had the respite been of a long duration; the 1st Battalion would be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and Anzac forces – the Australian and New Zealand Army Corps was also to serve at *Gallipoli* – had by then only been marking time until a complete withdrawal of the *Peninsula* could be undertaken.

This final operation had taken place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

**Lieutenant Owen Steele of St. John's, Newfoundland, is cited as having been the last soldier of the Mediterranean Expeditionary Force to step into the final small boat to sail from the Gallipoli Peninsula.*

Immediately after the British had evacuated the entire *Gallipoli Peninsula* in January of 1916, the Newfoundland Battalion was to be ordered to the Egyptian port-city of *Alexandria*, to arrive there on the 15th of that month. The Newfoundlanders had then immediately been transferred southward to the vicinity of *Suez*, a port at the southern end of the Canal which bears the same name, there to await further orders since, at the time, the subsequent destination of the British 29th Division had yet to be decided*.

***Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was soon to become a theatre of war.**

After a two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1st Battalion had boarded His Majesty's Transport *Alaunia* at Port Tewfiq, on March 14 to begin the voyage through the Suez Canal en route to France.



The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseilles, on March 22.

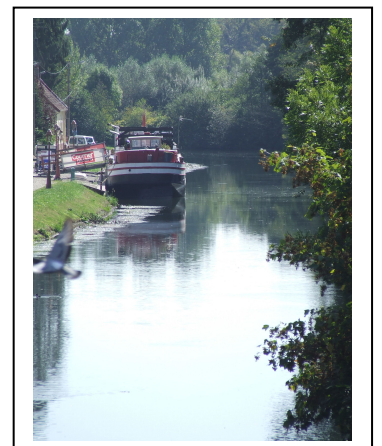
Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.



Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later *the Somme* was to have become a part of their history.

On April 13, the 1st Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be

introduced into the communication trenches of the *Western Front*. On the way, of course, as recounted in an earlier paragraph, it had been during this march that Private Prowse – and the 2nd Re-enforcement Draft from Ayr – had reported...*to duty*...with the parent Newfoundland Battalion at Louvencourt.

* * * * *

Just days following the Newfoundland Battalion’s arrival on the *Western Front*, two of the four Companies – ‘A’, and ‘B’ – were to take over several support positions from a British unit* before the entire Newfoundland unit was then ordered to move further up for the first time into forward positions on April 22.

**It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2nd Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.*

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, *the Somme*, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.

**Perhaps ironically, the majority of the Battalion’s casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action or died of wounds*.

It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the carnage of *the Somme* was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man’s-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

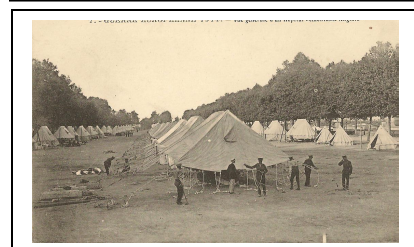
At Beaumont-Hamel on July 1, 1916, Private Prowse was wounded by shell-fire while serving with ‘D’ Company during that fighting of the first day of *the Somme*.

Having been injured in the left arm and leg, he was evacuated on the following day to the 87th Field Hospital, then immediately forwarded to an unspecified casualty clearing station before, on July 3, being transferred to the 1st General Hospital in the coastal town of Etretat.

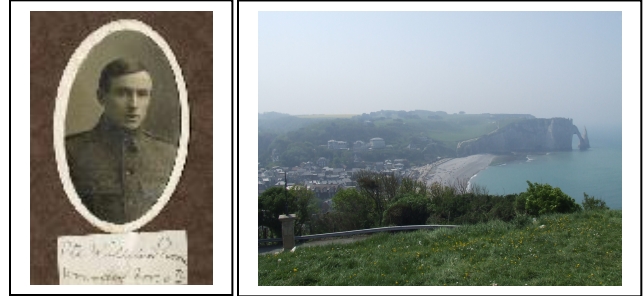

The son of Charles Prowse, carpenter with *W.J. Ellis (Contractor & Builder)* and of Catherine Prowse (née *Coady*) – to whom he allotted an allowance of 70 cents per day from his pay - of 53, Bannerman Street, in the capital city (and of various other addresses) - he was also brother to James-Joseph, John-Leo, Arthur, and to Francis-Benedict.

Considered *dangerously ill* on July 16, Private Prowse was reported as having *died of wounds* in the same 1st General Hospital at twenty-five minutes past eleven in the morning of July 18. He was buried in the churchyard there in Etretat.

William Patrick Prowse had enlisted at twenty-two years of age: date of birth in St. John's, Newfoundland, March 17, 1893 (from the Newfoundland Birth Register).
