
**The proximity of the headstones indicates this to be a mass grave – to be seen in the smaller photograph left above - as opposed to a single burial.*

His occupation prior to military service recorded as that of a *machinist* working with the family business, *James Rendell & Co., Bicycle Repairers & Gunsmiths*, for a weekly wage of \$5.00, Arthur James Rendell was a recruit of the First Draft.

He enlisted at the *Church Lads Brigade Armoury* in St. John's, capital city of the Dominion of Newfoundland, on September 3, 1914, – engaged at the daily private soldier's rate of \$1.10 (including a daily ten-cent field allowance). It was not until some weeks later, on September 29, that he was to undergo a medical examination, a procedure which found him to be...*fit for foreign service*.

Four weeks after his enlistment and two days after his medical examination, Private Rendell attested on October 1 before then embarking two days later again with the others of *The First Five Hundred*, on October 3, onto the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.



The ship sailed on the morrow to its rendezvous off the south coast of the Island where she was to join the convoy transporting the 1st Canadian Division across the Atlantic.

In the United Kingdom Private Rendell trained with the Newfoundland contingent: firstly in southern England; then in Scotland at Fort George – on the Moray Firth close to Inverness; at Edinburgh Castle – where it provided the first garrison from outside the British Isles; and later again at the tented *Stobs Camp* near the town of Hawick to the south-east of Edinburgh.



It was during this aforesaid period, in fact on December 18, only a week after having travelled north into Scotland, that Private Rendell received an appointment to the position of Regimental Assistant Armourer.

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south to undergo a final two weeks of training, as well as an inspection by the King, at Aldershot; meanwhile the two junior Companies, the later-arrived 'E' and 'F', were sent to Scotland's west coast, to Ayr, where they were to provide the nucleus of the newly-forming 2nd (Reserve) Battalion.

***On July 10, 1915, 'F' Company had arrived at Stobs Camp from Newfoundland, its personnel raising the numbers of the unit to battalion establishment strength, and thus permitting it to be ordered to active service. The 1st Battalion, Newfoundland Regiment, comprising those four Companies, 'A', 'B', 'C' and 'D', was thereupon attached to the 88th Brigade of the 29th Division of the (British) Mediterranean Expeditionary Force.**




It had then been during that period spent at Aldershot that Private Rendell of 'A' Company – he was not alone in doing so - had been prevailed upon, he on August 14, to re-enlist for the duration of the war*.

***At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of short duration, the recruits enlisted for only a single year. As the War progressed, however, this was obviously going to cause problems and the men were encouraged to re-enlist.**



On August 20, 1915, Private Rendell and his comrades-in-arms embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks where, a month later – having spent two weeks billeted in British barracks in the Egyptian capital, Cairo - on September 20, he disembarked with the 1st Battalion at *Suvla Bay* on the *Gallipoli Peninsula*.

The *Gallipoli Campaign* was to be a debacle: Flies, dust, disease, frost-bite, floods – and the casualties inflicted by an enemy who was to fight a great deal better than the British High Command* had ever anticipated – were eventually to overwhelm the British-led forces and it would be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.



**Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.*

It is likely that the news of the first withdrawal, that from *Suvla Bay* (see below), had already begun to circulate by the beginning of the month of December, although it is also likely that the Battalion personnel was still occupied with rectifying the damage caused by the freak rain-, snow-, and ice-storm which had flooded the positions of both sides during the last week of November and which had inflicted frost-bite and bronchitis on and amongst all concerned. The news of Private Rendell's promotion to the rank of lance-corporal on December 1 was surely noticed by only a few.

On the night of December 19-20, the British abandoned the area of *Suvla Bay* – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard. Some of the Battalion personnel was evacuated to the nearby island of *Imbros*, some to *Lemnos*, further away, but in neither case was the respite to be of a long duration; the 1st Battalion was transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British and the *Anzac* forces – the Australian and New Zealand Army Corps also served at *Gallipoli* – were now only marking time until a complete withdrawal of the *Peninsula* was undertaken. The operation took place on the night of January 8-9, the Newfoundland Battalion providing some of the rear-guard for this second occasion as well*.

When the British evacuated the entire *Gallipoli Peninsula* in January of 1916, Lance Corporal Rendell and the 1st Battalion were ordered to the Egyptian port-city of Alexandria, arriving there on the 15th of that month. The Newfoundlanders were then immediately transferred southward to Suez, one of the ports at the southern end of the Canal and which bears the same name, there to await further orders as, at the time, the subsequent destination of the 1st Battalion's 29th Division had not yet been decided*.

**Bulgaria had entered the conflict on the side of the Central Powers and Salonika was soon to become a theatre of war.*



After a two-month interim, on March 14, the Newfoundlanders embarked through Port Tewfiq, also at the southern end of the *Suez Canal*, for the French port of Marseilles, and disembarked there on March 22, en route to the *Western Front*.

Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train arrived at the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseilles. It had been a cold, miserable journey, the blankets provided for the troops having travelled unused in a separate wagon. De-training at the local station at two in the morning, the Newfoundlanders still faced a long march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they were marching on their way from the station. But some three months later *the Somme* would have become a part of their history.

On April 13, Lance Corporal Rendell's 1st Battalion paraded into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy. There its personnel would be billeted, would receive re-enforcements and, in two days' time, would be introduced into the trenches of the *Western Front*.

The Newfoundlanders would also soon be preparing for the British campaign of that summer, to be fought on the ground named for that meandering river, *the Somme*.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered they are those of the eight-hundred who went *over the top* in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later*.



**Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.*

There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been *killed in action or died of wounds*. It was to be the largest disaster ever in the annals of the British Army...and, perhaps just as depressing, the killing of *the Somme* was to continue for the next four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man’s-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.



Apparently born at East Boston, Massachusetts, in the U.S.A., the son of James Rendell, Blacksmith, machinist and businessman and of Rebecca Rendell (née *Pugh*)* of 18, King's Road in St. John's – to whom as of April 17, 1915, he had allocated a daily sixty cents from his pay – he was brother to sister Valeria (sic), also born in the United States, and to Howard-Edwin who was later born in St. John's.

**The couple, both having originated in Heart's Content, Newfoundland, was married in Boston on December 10, 1892.*

Lance Corporal Rendell was at first reported on July 1, 1916, as *missing in action* while serving with 'A' Company during the fighting of the first day of *the Somme*, at Beaumont-Hamel. He was then to be officially *presumed dead* some six months afterwards, on December 31, 1916.

However, a later letter dated July 14, 1917, and submitted by the G.O.C. 5th Corps, reported Lance Corporal Rendell's subsequent burial on or about that same date. His record was thus amended so as to read *killed in action*.
