

Private Sydney Ridout (also found as Rideout) (Regimental Number 1258), having no known last resting-place, is commemorated on the bronze beneath the Caribou in the Newfoundland Memorial Park at Beaumont-Hamel.



His occupation prior to military service recorded as that of a *fisherman* working for an annual three-hundred fifty dollars, Sydney Ridout presented himself for enlistment at the *Church Lads Brigade Armoury* in St. John's, capital city of the Dominion of Newfoundland, on February 22, 1915. He was engaged at the private soldier's rate of a single dollar per diem, plus a daily ten-cent *Field Allowance*.

On the morrow, February 23, he returned to the *CLB Armoury* on Harvey Road, on this second occasion to undergo a medical examination. It was a procedure which would pronounce him as being... Fit for Foreign Service.

It was to be five weeks less a day later, on March 29 that he was to undertake his attestation, to swear his *Oath of Allegiance*, the concluding official formality. At that moment Sydney Ridout became...a soldier of the King.

There now passed a further lengthy period of three weeks and three days before, on April 22, 1915, Private Ridout, Number 1258, embarked in the harbour of St. John's for...overseas service...with the two-hundred forty-nine officers and...other ranks...of 'E' Company onto the Bowring Brothers' vessel Stephano en route for Halifax.

There appear to be no details of how or where he may have spent those two intervening periods before taking ship for...overseas service; Private Ridout may have returned home to Moreton's Harbour, and perhaps even to work – but this is mere speculation.

Having arrived in Halifax, on April 24 at eleven-thirty in the evening the detachment began its trans-Atlantic passage on board the trans-Atlantic liner SS *Missanabie* from Nova Scotia to Liverpool. The vessel arrived in that English west-coast port-city on May 2 or 3 – the two dates are recorded although the second may well have been the date of disembarkation.

The Newfoundlanders on this occasion had sailed from Halifax in the company of the Canadian Army Service Corps Railway Supply Depot.

From Liverpool the contingent travelled northwards by train to the Scottish capital, Edinburgh where, on May 4, 'E' Company joined 'A', 'B', 'C' and 'D' Companies which had already taken up station as the garrison at the historic Castle, the first troops from outside the British Isles ever to do so.

Private Ridout's 'E' Company, however, was to have but a few days to savour the charms of the Scottish capital.

\* \* \* \* \*

Some seven months before that May 4, in the late summer and early autumn of 1914 there had been a period of training of five weeks on the shores of *Quidi Vidi Lake* in the east end of St. John's for the newly-formed Newfoundland Regiment's first recruits – these to become 'A' and 'B' Companies - during which time the authorities had also been preparing for the Regiment's transfer overseas.

This first Newfoundland contingent was to embark on October 3, in some cases only days after a recruit's enlistment and/ or attestation. To become known to history as the *First Five Hundred* and also as the *Blue Puttees*, on that day they had boarded the Bowring Brothers' vessel *Florizel* awaiting in St. John's Harbour.

The ship had sailed for the United Kingdom on the morrow, October 4, 1914, to its rendezvous with the convoy carrying the 1<sup>st</sup> Canadian Division overseas, off the south coast of the Island.

Once having disembarked in the United Kingdom this first Newfoundland contingent was to train in three venues during the late autumn of 1914 and then the winter of 1914-1915: firstly in southern England on the Salisbury Plain; then in Scotland at Fort George – on the Moray Firth close to Inverness; and lastly at Edinburgh Castle – where, as recorded beforehand, it was to provide the first garrison from outside the British Isles.

Only days after 'A' and 'B' Companies had taken up their posting there, on February 16 of 1915, 'C' Company – the first re-enforcements for the original contingent\* - would arrive directly – through Liverpool of course - from Newfoundland. On the final day of the month of March it had been the turn of 'D' Company to arrive – they via Halifax as well as Liverpool – to report...to duty...at Edinburgh.

\*This contingent, while a part of the Newfoundland Regiment, was not yet a battalion and would not be so for a further five months – as will be seen below.

\* \* \* \* \*

Seven days after the arrival of Private Ridout's 'E' Company in the Scottish capital, on May 11 the entire Newfoundland contingent was ordered elsewhere.

On that day, seven weeks into spring – although in Scotland there was apparently still snow - the unit was dispatched to *Stobs Camp*, all under canvas and south-eastwards of Edinburgh, in the vicinity of the town of Hawick.

It was to be at *Stobs Camp* that the Newfoundland contingent would eventually receive the re-enforcements from home – 'F' Company which arrived on July 10, 1915 - that would bring its numbers up to that of British Army establishment battalion strength\*. On that date the newly-formed 1<sup>st</sup> Battalion of the Newfoundland Regiment was thus now available to be ordered on...active service.

\*This was approximately fifteen hundred, sufficient to furnish four 'fighting' companies, two re-enforcement companies and a headquarters staff.

At the beginning of that August of 1915, the four senior Companies, 'A', 'B', 'C' and 'D', were then sent south from *Stobs Camp* to undergo a final two weeks of training, as well as an inspection by the King, at *Camp Aldershot*. This force, now the 1<sup>st</sup> Battalion of the Newfoundland Regiment, was thereupon attached to the 88<sup>th</sup> Brigade of the 29<sup>th</sup> Division of the (British) Mediterranean Expeditionary Force.

Meanwhile the two junior Companies, 'E' – as seen, the last arrived at Edinburgh - and the aforementioned 'F', were ordered transferred to Scotland's west coast, to Ayr, there to provide the nucleus of the newly-forming 2<sup>nd</sup> (*Reserve*) Battalion.

Private Ridout, however, although having left Newfoundland as a soldier of 'E' Company, was not to be posted to the Regimental Depot but to southern England.

When he had been apprised of this change in plans seems not to be recorded – nor why he was selected - but Private Ridout was one of the few from 'E' Company who were to swell the ranks of the units posted to *Aldershot* - thus he became a soldier of 'C' Company. And it was during the period while he was at *Camp Aldershot*, and as was the case with the great majority of the Newfoundland troops there, that Private Ridout was prevailed upon to re-enlist... for the duration of the war. This he did on August 15\*.

\*At the outset of the War, perhaps because it was felt by the authorities that it would be a conflict of only short duration, the recruits enlisted for a limited period of only a single year. As the War progressed, however, this was likely to cause problems and the men were encouraged to re-enlist. Later recruits signed on for the 'Duration' at the time of their enlistment.

On August 20, 1915, Private Ridout and his 1<sup>st</sup> Battalion embarked in the Royal Navy Harbour of Devonport onto the requisitioned passenger-liner *Megantic* for passage to the Middle East and to the fighting against the Turks. There, a month later – having spent some two weeks billeted in British barracks in the vicinity of the Egyptian capital, Cairo - on September 20, the 1<sup>st</sup> Battalion was to land at *Suvla Bay* on the *Gallipoli Peninsula*.

Private Ridout, however, was by that time no longer among the Newfoundland unit's ranks.



On September 19, instead of having been trans-shipped and then forwarded on to *Suvla Bay*, Private Ridout had been taken off *Ausonia* at Mudros Bay on the Greek island of Lemnos and admitted into the 1<sup>st</sup> Stationary Hospital there on the following day. He was suffering from diarrhæa.

There appear to be no further records of Private Ridout during the ensuing months – except for a paper which implies that he was still receiving medical attention in the 1<sup>st</sup> Stationary Hospital on October 21 - until he was reported to be...with Battalion...on March 1 of the following year, 1916.

The likelihood is that at some point after treatment and convalescence he had been discharged from Mudros and transported...to duty...to a British Base Depot, surely Sidi Bishr at Alexandria. From there at the end of February he would have travelled down the length of the Suez Canal, north to south, to where the Newfoundland Battalion was encamped in the vicinity of Port Suez.

In the meantime while Private Ridout was under medical care, when the Newfoundlanders had landed from their transport ship at *Suvla Bay* they would disembark into a campaign that was already on the threshold of collapse.



Not only in the area where the Newfoundland Battalion were to serve but, even ever since the very first days of the operation in April of 1915, the entire *Gallipoli Campaign*, including the operation at *Suvla Bay*, had proved to be little more than a debacle:

Flies, dust, disease, the frost-bite and the floods – and of course the casualties inflicted by an enemy who was to fight a great deal better than the British High Command\* had ever anticipated – were eventually to overwhelm the British-led forces and those of the French, and it would finally be decided to abandon not only *Suvla Bay* but the entire *Gallipoli* venture.

\*Many of the commanders chosen were second-rate, had been brought out of retirement, and had little idea of how to fight – let alone of how to win. One of the generals at Suvla, apparently, had handed in his resignation during the Campaign and had just gone home.

November 26 would see the nadir of the Newfoundland Battalion's fortunes at Gallipoli; there was to be a freak rain-, snow- and ice-storm strike the *Suvla Bay* area and the subsequent floods had wreaked havoc amongst the forces of both sides. For several days, survival rather than the enemy was to be the priority.

There were to be many casualties on both sides, some of them, surprised by the sudden inundation of their positions, fatalities who had drowned in their trenches – although no Newfoundlanders were to be among that number. Numerous, however, were those afflicted by trench-foot and by frost-bite.

By this time the situation there was daily becoming more and more untenable, thus on the night of December 19-20, the British had abandoned the entire area of *Suvla Bay* – the Newfoundlanders, the only non-British unit to serve there, to form a part of the rear-guard.

Some of the Battalion personnel had been evacuated to the nearby island of Imbros, some to Lemnos, further away, but in neither case was the respite to be of a long duration; the 1<sup>st</sup> Battalion was to be transferred only two days later to the area of *Cape Helles*, on the western tip of the *Gallipoli Peninsula*.

The British, Indian and Anzac forces – the Australian and New Zealand Army Corps was also to serve at Gallipoli – had now only been marking time until a complete withdrawal of the Peninsula could be undertaken.

This final operation would take place on the night of January 8-9, the Newfoundland Battalion to furnish part of the British rear-guard on this second occasion also.

Immediately after the British evacuation of the *Gallipoli Peninsula*, the Newfoundland unit had been ordered to the Egyptian port-city of Alexandria. On January 14, the Australian Expeditionary Force Transport *Nestor* had arrived there with the 1<sup>st</sup> Battalion on board. The vessel was to sail just after mid-day on the 16<sup>th</sup>, on its way southwards down the Suez Canal to Port Suez where she arrived on the morrow and where the Newfoundlanders landed and marched to their encampment.



There they were to await further orders since, at the time, the subsequent destination of the British 29<sup>th</sup> Division had yet to be decided\*.

\*Bulgaria had entered the conflict on the side of the Central Powers, and Salonika was already becoming a theatre of war.

It was to be just more than six weeks into the period that was now to follow at Port Suez, on March 1, that Private Ridout, after an absence of more than five months, would report back to his unit.

\* \* \* \* \*

After that two-month interim spent in the vicinity of Port Suez, the almost six-hundred officers and other ranks of the 1<sup>st</sup> Battalion were to board His Majesty's Transport Alaunia at Port Tewfiq, on March 14 to begin the voyage back up through the Suez Canal en route to France. The Newfoundlanders would disembark eight days afterwards in the Mediterranean port-city of Marseille, on March 22.



Some three days after the unit's disembarkation on March 22, the Newfoundland Battalion's train was to find its way to the small provincial town of Pont-Rémy, a thousand kilometres to the north of Marseille. It had been a cold, miserable journey, the blankets provided for the troops having inexcusably travelled unused in a separate wagon.



Having de-trained at the local station at two o'clock in the morning, the Newfoundlanders were now still to endure the long, dark march ahead of them before they would reach their billets at Buigny l'Abbé.

It is doubtful if many of those tired soldiers were to pay much attention to the slow-moving stream flowing under the bridge over which they then marched on their way from the station. But some three months later the Somme was to have become a part of their history.

On April 13, the 1<sup>st</sup> Battalion subsequently marched into the village of Englebelmer – perhaps some fifty kilometres in all from Pont-Rémy - where it would be billeted, would receive re-enforcements from Scotland via Rouen and, in two days' time, would be introduced into the communication trenches of the *Western Front*.

Just days following the Newfoundland Battalion's arrival on the *Western Front*, two of the four Companies – 'A', and 'B' – were to take over several support positions from a British unit\* before the entire Newfoundland unit was to then be ordered to move further up for the first time into forward positions on April 22.

\*It should be said that the Newfoundland Battalion and two-hundred men of the Bermuda Rifles who were serving at the time in the 2<sup>nd</sup> Lincolnshire Regiment Battalion, were then the only units at the Somme from outside the British Isles - true also on the day of the attack on July 1.

Having then been withdrawn at the end of that April to the areas of Mailly-Maillet and Louvencourt where they would be based for the next two months, the Newfoundlanders were soon to be preparing for the upcoming British campaign of that summer, to be fought on the ground named for the languid, meandering river, the Somme, that flowed – and still does so today – through the region.

If there is one name and date in Newfoundland history which is etched in the collective once-national memory, it is that of Beaumont-Hamel on July 1 of 1916; and if any numbers are remembered, they are those of the eight-hundred who went over the top in the third wave of the attack on that morning, and of the sixty-eight unwounded present at muster some twenty-four hours later\*.

\*Perhaps ironically, the majority of the Battalion's casualties was to be incurred during the advance from the third line of British trenches to the first line from where the attack proper was to be made, and while struggling through British wire laid to protect the British positions from any German attack.



There are other numbers of course: the fifty-seven thousand British casualties incurred in four hours on that same morning of which nineteen-thousand were recorded as having been killed in action or died of wounds.

It was to be the greatest disaster ever in the annals of the British Army...and, perhaps just as depressing, the carnage of the First Battle of the Somme was to continue for a further four and a half months.

In fact, Beaumont-Hamel was a commune – it still exists today – at the time comprising two communities: Beaumont, a village on the German side of the lines, and Hamel which was behind those of the British. No-Man's-Land, on which the Newfoundland Memorial Park lies partially today, was on land that separated Beaumont from Hamel.

The son of Ambrose Ridout (*Rideout* in the 1911 Census), fisherman, and of Elizabeth Ridout (née *Nicholas*) – to whom he had allotted a daily allowance of seventy cents from his pay - of Cottle's Island, Moreton's Harbour (of *Whale Gulch* in the 1904 Business Directory and of Luke's Arm in the 1911 census), he was also oldest brother to Caleb, James, Bertha, Sarah, Winnie and Simon.



\*The couple had married on May 21, 1892.

Private Ridout was reported as...missing in action...at Beaumont-Hamel on July 1, 1916, while serving with 'C' Company on the first day of...First Somme. Some six months later, on December 31, he was officially...presumed dead.

Sydney Ridout had enlisted at a *declared* twenty-one years of age: date of birth in Whale Gulch, Newfoundland, September 13, 1894 (from the Newfoundland Birth Register).

Private Sydney Ridout was entitled to the 1914-1915 Star, as well as to the British War Medal (centre) and to the Victory Medal (Inter-Allied War Medal).
